My daughter is a resident there. She got into this program by the Grace of God and the interest of Kurt Ellison, MS, who runs the program.

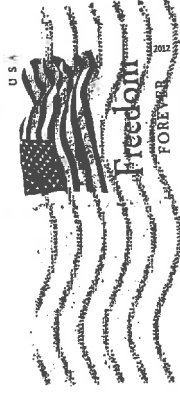

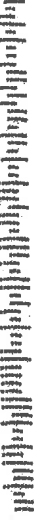



Thank you for the help you provided for my family and my daughter.

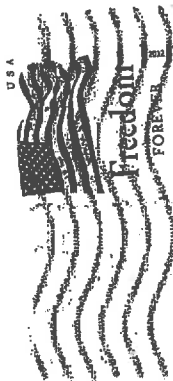


