As a transfer of appropriations, the State Board of Health was given permission to condense its entire appropriations for the fiscal year 1945-46 into six lump sum items. This permission was granted to facilitate the reorganization of the financial management of the State Board of Health, and to enable the department to eliminate the practice of supplementing salaries from Federal funds. The condensation of these appropriation accounts had been recommended by the State Auditor and the Comptroller General for one year only in order to assist in the reorganization of the department.
