I received a call from Dr. Quinn asking me to go to BWD and assess the possible damage that may have been done to BWD campus due to an event that occurred the previous night. I arrived on campus and did a visual inspection of the exterior/interior of the Main Academic, CATE, Science and Gym buildings. I discovered that the front office, traffic control and guidance areas of the main building had been entered and vandalized. There were 6 windows and two doors that were not secured, and I suspect that one was used to gain entry. The juveniles that entered ransacked the mentioned areas, took a fire extinguisher and expelled it in the front office and behind the main building. The CATE building was entered but none of the classes were disturbed. I did discover that one of the hallway doors would not stay secured, though it was locked. The door to the Gym was not secured but there was no obvious damage. The Science building was not entered but I did discover that one of the classroom doors had been left unsecured. There will be a need to repair and/or replace several items, to include computer monitors, copiers, and doors. I took 33 pictures of the most damaged areas.



On February 26, 2016 at about 20:30, the girls of willow unit on west wing was finishing up their snacks in the dining area when we heard glass shattering. I JS Khalilah Prescott turned around and looked at the other staff asking what that was. At that time more glass started shattering from different rooms of the house and several male juveniles started entering willow unit. I JS Prescott immediately told the girls to go to their rooms. The male juveniles was coming from east wing rooms and coming through the windows in the living room area. One of the male juveniles was juvenile [REDACTED] (#372237). When juvenile [REDACTED] entered willow unit with the other male juveniles, he started yelling saying " we in this bitch, we turned the fuck up, we going to fuck shit up in this bitch, and we going to make sure no body work this campus. Juvenile [REDACTED] and the other juveniles started kicking and punching the glass out almost every window in willow unit. One of the male juveniles took the fire extinguisher that was by the trash can and started busting the window on the back the door and in the female rooms. One juvenile started kicking the doors of the camera room ant the UM office. That same juvenile picked up one of the dining room table chairs and tried to bust the windows out of the camera room and the UM office. While that was going on, some of the other juveniles started yelling saying "man let's go let's go they coming!!!" The doorbell of willow rung and JS Prescott went to open the door for JSV Merial Hunter and public safety. When they entered the t home, I told them that the male juveniles ran to the back of the house. Public safety ran to the back and came back to the living room area of the house with juvenile [REDACTED] Public safety left out of willow with juvenile [REDACTED] About 3 minutes later Juvenile [REDACTED] and some of the other juveniles entered willow unit again from one of the rooms on east wing. Hunter told me JS Prescott and JS Jekeria Henderson to put the girls in the bathroom on their hall. JS Prescott and JS Henderson immediately did what we was ask to do. That's when juvenile [redacted] came to west wing asking to speak to the girls and that he wanted to fuck something because he don't give a fuck and he will fuck in front of staff and all. I JS Prescott told [redacted] to go on because I was not going to open the bathroom. Juvenile [redacted] continue to ask to speak to the girls and I JS Prescott continue to tell him no. Juvenile [redacted] turned around and notice one of the male juveniles spraying the floor with the fire extinguisher and told him to chill out. Then juvenile [redacted] went on east wing entering the bathroom with the female juveniles and staff. I JS Prescott overheard JSV Hunter telling him to get out and he did. Juvenile [redacted] and the other juveniles that was still in willow noticed assistance was coming in willow and they left. The girls was asked to come from out the bathroom and get their blankets because they were leaving willow to go stay somewhere else. All 5 of the females and staff left willow and was reassigned to magnolia unit on birch wood campus




On 2/26/2016 at 2005, All the juveniles listed above were involved in the incident that occurred in Cypress Unit. JS I Jesse White called over that radio that there was a fire on Cypress A-pod. I, JS II J. Brown informed JS IV Williams of the fire that was on the A-Pod. A few seconds later JS I Jesse White called over that radio stating that the fire was out. At this point the fire alarm inside Cypress began to go off, and all types of incidents began to occur. A fire on B-Pod was lit by one of the juvenile listed above. Juveniles began ripping sinks out the wall and throwing them into the glass leading into the second control room. The juvenile that were housed in B-pod broke out all the windows in second control room and the windows leading into c-pod. JS II Walls stated that there were juveniles from B-pod that were climbing through the door windows. JS II Walls were assaulted by [redacted] with the red extinguisher on the right elbow. Juveniles on both B and C pod were breaking and smashing glass, breaking the tv, and ripping sinks out the walls. Juveniles in B-pod smashed all the camera surveillance equipment inside the second control room. One of the juvenile that were listed above used a red fire extinguisher to hit JS IV Williams in the back in the courtyard. At 2025 I, JS II J. Brown witnessed Juvenile [redacted] at a fire at the back door of C-pod. Juvenile [redacted] used tissue and paper towel to start the fire and Juvenile [redacted] a green shirt on top of the fire. All staff were release from the pods at this point. Once all the juveniles were inside the courtyard they began to destruct the entire unit. Juvenile [redacted] threw a red fire extinguisher through the main control room left window and proceeded to climb through the window and began to destroy all surveillance equipment. Juvenile [redacted] picked the red fire extinguisher up again and threw it through the right side window. At this point PSO let me out the with the master key to safety. Juvenile [redacted] refused to allow AUM Stevens to close the vestibule door and that is when the Juveniles from all pod exited into the vestibule and I, JS II J. Brown used the master to allow more staff to assist. Juvenile from all pod rushed the front door and pushed JS IV Williams into the right side of the wall, which she fall down near the cafeteria cart. 

On February 26, 2016, I, Kenneth L. James, received a call from AUM Curtis Wilson in Holly Unit requesting assistance in Cypress Unit due to the juveniles causing a major disruption. As I arrived on campus at approx....2015 hrs, I immediately ran to Cypress Unit along with Mr. Sessions, Director Murray, and Major Angela Scott. Once at Cypress Unit, I was informed that there were male

juveniles in Willow Unit threatening the females, so I commandeered a white van that was being driven by officer Ashia Smith along with Officers Clarence Turner and PSO Dana Scott and headed towards Willow Unit. While in route, I saw juvenile [REDACTED] running across the road from the Willow Lane fence to the Willow Lane Chapel. I parked the van in front of Willow Lane Chapel and ran behind the chapel between the chapel and the Willow Lane Infirmary administration building and caught up to juvenile [REDACTED]. When I got within a few feet of juvenile [REDACTED] he turned around and stated "back the fuck up" while holding a pair of red handle scissors in his right hand and pointing it in my direction. I told juvenile [REDACTED] to give me the scissors, but he continued to tell me to back up and that he was not going to lock up because he did not do anything. I stated to juvenile [REDACTED] several times that I did not know what he did or why he was running but holding the scissors and telling me to back up was a threat to my life. Juvenile [REDACTED] stated several times he did not care, he was not going to lock up. After telling juvenile [REDACTED] that I, nor officer Scott or Turner was going to touch him and that officer Turner would walk him back to Cypress Unit without restraints in return for the scissors, Juvenile [REDACTED] gave the scissors to PSO D. Scott. After receiving the scissors, PSO D. Scott and I ran over to Willow Unit on foot to assist. Immediately after arriving, I heard over the radio that there were 4 juveniles that entered into the Police Annex building. PSO D. Scott and I then turned around and began running from Willow Unit to the Police Annex via the road in front of the Willow Lane Chapel. As we approached the rear of the building, I noticed Mr. Andy Broughton walk over to the Police Annex and 4 juveniles immediately exit a rear door and run towards their right around the building. PSO D. Scott and I, along with a group of other officers ran to our right around the right side of the Palmetto building from the rear in an attempt to meet them in the front. As I came around the front of the Palmetto Building, I noticed the illuminated tail lights of 2 vehicles, one grey car and one black car. As the grey vehicle pulled back then turned to exit the parking lot, I noticed the driver was Police Supervisor Maurisha Scott. I then looked into the black vehicle and noticed 3 juveniles inside of the vehicle. As I grabbed the passenger's side door handle, Juvenile [REDACTED] yelled from the passenger's seat "go go go". Juvenile [REDACTED] was driving and quickly put the vehicle in reverse and backed the vehicle up in a high speed. Due to me holding the lock door handle, I was pulled, spun around and hit by the passenger's side mirror. The vehicle then backed into another grey vehicle parked in front of the Police Annex building. I, along with PSO D. Scott and Officer Kendric Holland ran towards the vehicle and I heard Juvenile [REDACTED] scream "Hit those bitches" as Juvenile [REDACTED] attempted to put the vehicle in drive, Juvenile [REDACTED] exited out of the back seat allowing PSO D. Scott to enter. Juvenile [REDACTED] then turned the vehicle in the direction of Officer Holland and myself and drove toward us at a high rate of speed. Officer Holland and I moved out of the way of the vehicle, being missed by a few inches as the vehicle passed. As the car passed, I noticed PSO D. Scott holding on to the driver of the vehicle from the rear, causing him to hit the curb of the parking lot and stop in the grass approx... 50 feet passed the curb. Officer Holland and I then ran toward the vehicle's driver's side to assist PSO D. Scott in removing Juvenile [REDACTED] from behind the wheel. Juvenile [REDACTED] began kicking and fighting in an attempt not to be removed from the vehicle. After several minutes of resisting, Juvenile [REDACTED] was placed in restraints with the assistance of several officers to include Officer Holland, PSO Scott, and AUM Curtis Wilson. While staff were attempting to remove Juvenile [REDACTED], Juvenile [REDACTED] exited the vehicle and ran towards the Palmetto building. After securing juvenile [REDACTED] I heard a call for assistance coming from the rear of the John G. Richards Cafeteria. I, along with a group of officers, ran towards the rear of the cafeteria where we encountered juvenile [REDACTED] resisting restraint. I along with several other officers assisted in placing juvenile [REDACTED] in restraints and searching him. While searching him, Juvenile [REDACTED] stated they broke into a vending machine and stole several snacks which were removed from both leg areas of his green jogging pants. I then proceeded to look for Juvenile [REDACTED] along with PSO Scott. During our search, I noticed the office windows to the office belonging to Security Compliance Coordinator Bitry Cooper-Charles were broke. I entered the building and Officer Clarence Turner and I cleared the building. I then instructed Officer Turner to remain in the building, as it was unsecure until he was properly relieved. As we, along with several other officers, searched the area around the Information Technologies buildings, Juvenile [REDACTED] was found hiding under a tractor between the IT building and the barn behind the building. I, along with PSO's M. Scott, J. Smith, and J. Pugh then began to walk the campus and search for other missing juveniles. As we searched around the Willow Lane Infirmary, we were informed by a nurse that she was speaking with a friend who stated that there is a juvenile at the Dollar Tree on Broad River Road. I then received the phone from the nurse and spoke with the individual who stated she was standing with a juvenile in front of the Dollar Tree on Broad River Road who says he escaped. The PSO's and I then commandeered a vehicle from the nurses and exited the campus while informing Deputy Director Williams and Mr. Sessions of the call. Once I arrived at the Dollar Tree, Juvenile [REDACTED] was standing between Investigator Yolanda Reed and a Richland County deputy in handcuffs. I then received Juvenile [REDACTED] and placed him in the back of my vehicle with the PSO's. Juvenile [REDACTED] then agreed to provide information on how he escaped and the events that led up to the incident. Juvenile [REDACTED] stated "when we (Cypress dorm) were told we were not going back to school, the boys said they were going to riot and break out of the unit and run down to Holly Unit and break in to fight the other kids". Juvenile [REDACTED] continued by stating "me, [REDACTED], and [REDACTED] planned to escape after the boys got out, but I think only me and [REDACTED] got out". Juvenile [REDACTED] then directed us to the back Willow Lane Campus in front of Human Resource Building where he pulled the rebar off of a weather drain that leads under the fence. Juvenile [REDACTED] showed by verbal direction and described that he went through the drain and ran across SCDC property until he got to Broad River Road, where he continued until he reached the Dollar Tree where his mother is an employee and was closing the store. Juvenile [REDACTED] was placed into a wet cell in the Midlands Evaluation Center's Pearl Unit. Upon returning to BRRC, the PSO's and I proceeded directly to Birchwood High School

due to calls of potential movement in the school. As we entered the rear parking lot, we met with Mr. Sessions to brief him on the previous activities and from there we noticed juveniles on top of the Magnolia Building. Juveniles [redacted] [redacted] [redacted] and [redacted] were all on top of the unit refusing directions to get down. After several directions and discussions with Deputy Director Williams and Director Murray, all juveniles climbed down from the building. Juvenile [redacted] once down from the building, refused to be placed in restraints and began to run to his right in front of Catawba Unit towards the BARJ building. Juvenile [redacted] was caught and restrained by several staff on the side of the BARJ building. I then proceeded over to show Mr. Broughton where juvenile [redacted] escaped from the facility when I received a call that there was a fire in Poplar Unit. I then proceeded with Mr. Broughton over to Poplar Unit B-Pod. Upon entering, there was a strong aroma of smoke and the room was hazy. Inside of the restroom, to the left, in front of the toilet was the residue of something that was burnt. I then instructed all officers to begin strip searching the juveniles and placing them in a contained area. Shortly after, Holly Unit called for assistance. Several juveniles were upset and refusing to go to bed but was not causing any visible damage at that time. End of Report.

On 2-26-16, at approximately 2045 while the female juveniles [REDACTED] (#409664, B/F, 15yo, Horry), [REDACTED] (#405784, B/F, 15yo, Charleston), [REDACTED] (#389520, B/F, 17yo, Beaufort), [REDACTED] (#377900, W/F, 16yo, Aiken), and [REDACTED] (#425945, H/F, 16yo, Charleston) were eating their snacks in the dining area, they heard glass shattering. At this time Juvenile's [REDACTED] (#372237, 16yo, B/M, Anderson), [REDACTED] (#396677, B/M, 16yo, Orangeburg), [REDACTED] (#388917, 15yo, B/M, Richland), and [REDACTED] (#345738, B/M, 16yo, Williamsburg) entered the house threatening to hurt the girls. Staff immediately called for assistance. Staff tried to secure the girls to prevent the males juveniles from attacking them, but there were too many to handle. Juveniles [REDACTED] and [REDACTED] stated "I'm trying to fuck something tonight!" Staff put the female juveniles in the bathroom to secure them. Juv [REDACTED] got a fire extinguisher and began spraying the floor. He then threw the fire extinguisher across the room which landed on staff Merrial Hunter's foot. Juv [REDACTED] also pushed JS Henderson to the floor. The male juveniles then made their way to the back of T-Homes and burst out more windows in the girls rooms and then tried to force their way inside the bathroom where staff had the girls secured. When PSO's arrived for assistance the male juvenile's then ran out of the house. The girls were then asked to come out of the bathroom and get their blankets so that they could all go stay somewhere else. All five of the girls were reassigned to Magnolia Unit on Birchwood Campus. Nothing further at this time.

Juvenile [REDACTED] (#409664) expressed to ISO Courtney Washington that she wanted to come home due to an event that occurred over the weekend at Willow Lane T-Home. The juvenile stated that male juveniles broke into the Willow Lane T-Home and proceeded to sexually assault the female juveniles. 


