away from Seabrook when I was
14 years old. This was heirs
property that was finally cleared

My neighbor is Pearl and George
Green. I played with all the Green
gang. We played and ran in the
field, woods and creek. When I
moved back there in Oct 1997,
the Greens made life Hell for me
and my son. The Greens wanted
me to sell my property and I
refused, my mother and siblings
refused, as well. I lived there for
a few years only.

The Greens along with other people break into my home and applied a chemical substance all over my home. I have come home and found my personal belongings shrewn on my yard, a Black Lab was killed by the Greens and 8 Rottweiler puppies. All of my cars were destroyed with that chemical. My sons car's are being vandalized today with chemical abuse by landlord, employee and employer. Sheriff P. J. Tanner has contacted individuals where we live and these break into our home and automobile. This chemical has caused dental problems, it is dry and bitter, I have lost all my natural dentures. I have been fitted for dentures which I cannot afford at this time. I live in Lakeview Mobile Home, the landlord, employees break into my home spraying and applying chemical. This chemical makes us sweaty, as well as itchy.

The landlord and maintenance crew has applied this substance inside the air duct. I can see the application outside on the system. I try to run water on it, however the chemical has dried and looks like white paint on the unit outside. When the air blows inside, there is fine particles of debris blowing all over the furniture, floor and everywhere.

This vandalism has been going on for 13 years, I am tired. The last time I spoke with Carl Brown at Sheriff Dept. he was rude and arrogant. The Green's have a son, Paul Green who recently retired from the Sheriff Dept. I know for a fact the Paul Green along with his parents and others are responsible for the onset of crimes done to my property. I know the continuation is maneuvered by P.J. Tanner and Carl Brown.

I lived in Savannah, Ga for 10 years and the same vandalization happed in my home and auto, while I lived there. Tanner contacted Savannah Police to continue his criminal abuse against me. I saw and spoke with a neighbor from Seabrook and she confirmed what I just wrote in this letter. I am stalked and followed everywhere, my cell is tapped, my mail is ransacked, tenants have wrongfully tapped into my metere box and stealing free electricity and cable from me. I have complained to SCEG and Hargray. I have Complained to the Sheriff. No one has done anything, I cannot complain to the landlord because they are the per-putrators, along with the tenants. The landlord has to meet numbers and dollars to lace their pockets, therefore, they do not care who becomes the sacrificial lamb. My SCEG is extremely high due to theft from other tenants. I live on Social Security. 4

I made a mistake during this event. I sent a letter to Paul Green and I did threaten him.

However, I was disappointed with his behavior. This was about 13 yrs. ago.

When his sister Lula Green Delaney was incarcerated for drug trafficking I supported her and the entire Green Clan. I lived in Columbia when she served her time. I visited and counseled with her. We prayed together, I ran errands for her, there was an 8 year old daughter who cried for her mommy everyday.

As I write this letter, the AC is running, the air is bitter, salty and a foul smell in the home. I change filter 3 time during the month and filters are jet black with debris from chemical inside unit. I clean constantly. The chemical is everywhere in my home. My refrigerator, stove, washer, floors, walls, bath fixtures, closet even outside on the lawn.

P. J. Tanner told William Ladson that I was "crazy, a crackhead and alcoholic". This is not true, this was Tanner's low-down dirty tactic to draw others into his corruption against me. This is his cover up to protect the Green Clan. Most people in Beaufort are afraid of Tanner so they go along with "his" Law.

I am asking you to contact Tanner and tell him to stop harassing me and vandalizing my property. I am a citizen of these United States, I work and pay taxes. My husband, father and brother served in the military to defend this country. The Green family and no one will ever claim my property. It is not mine to sell. The Heirs are my ancestors. They worked, fought, shed blood to maintain a life. I will not "mock their legacy" by selling out.

I purchased a 2013 Elantra on Sept 3, 2014. My car has lost the clean, new smell because it is being vandalized by a chemical. I have to wash it daily. When I wipe the exterior there is black slimy residue on the rag. I have monthly payments on this car. This is the first car I have had since 2005. I am 65 years-old and should not have to live this way. I sleep in a chair near the window to watch my car at night. I try to park close to the entrance at grocery stores and other places. I have to rush to get back to my car. I have driven my car for 1 week and I can feel the performance is not the same. Someone has tampered with my gas cap, I smelled gas this morning as I drove to the store. I am very tired of 13 years of harassment, slander disrespect and lies about me.

When I confronted P. J. Tanner 13 years ago, he said I was wrong and the Greens did not vandalize my properties. He never did a thorough investigation into the matter. I have called to set an appointment and that was cancelled. It is not fair the Greens are free and I am still incarcerated and still a victim... Tanner is covering for Paul Green. He needs to cover me, as well. Governor Haley, I need your help and I am asking for your help.

I work part-time as a caregiver and homemaker. I take care of three homes and one office. I pick up 3 children from school everyday, I must have safe and dependable transportation to perform these tasks. It is not fair that I must continually suffer for the mistakes of other individuals.

The gas cover has been broken on my car. My car is making a funny noise, they have opened the hood and sprayed this chemical inside the engine.

Inside the car is dusty, smelly, hot and putrid. The car is vibrating as I drive along, the wheel covers are rusted from the chemical abuse. There was nothing wrong with this car when I purchased it 3 weeks ago. This chemical penetrates and erodes and destroys anything that has contact with it. It appears that I will not have a car within a few months. They are slowly destroying my car. My clothes have rusted spots, I can not remove these spots. I work long, hard hours to earn my living and I do not appreciate what P. J. Tanner has done and continues to do. He should be tired just as I am tired. My home is destroyed with this chemical, my security alarm is tampered with by the landlord.
