Mr. Poore called the meeting to order and Councilman Wright gave the invocation.

Mr. Poore announced that the Research & Development Committee of the Appalachian Council of Governments has invited County Council to a luncheon on the 20th of January, 1981 to get the Council's input on this years program at COG. Mr. Poore accepted for County Council and would like for everyone to attend.

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to approve the December 16, 1980 minutes as corrected.

Mr. William L. Watkins asked Council to approve a Resolution for Baxter/Kelly, Inc. He stated that Baxter Kelly, Inc., which leases property from Anderson County under a Lease Agreement dated June 1, 1972 entered into as a part of an industrial revenue bond matter, has given the County notice that it desires to exercise its option under Section 11.3 of the Lease to purchase a 30,000 square foot part of the leased land, which is vacant land. It is found that Baxter Kelly has complied with all the conditions set out in the Lease for the exercise of this option. Council received as information since the County Attorney was not present.

Mr. Poore welcomed the new Councilmembers and announced that it was necessary to elect a new Vice-Chairman. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to elect Mr. Daniel A. Rhodes as vice-chairman.

Mr. David Watson discussed sealed bids for asphalt for the months of January, Feb. & March, 1981 to be picked up at plant. On the motion of Mr. Bratcher, seconded by Mr. Kinley, Council voted unanimously to split the business with Pickers & Tribble Construction Companies for \$22.25 per ton.

Mr. David Simpson stated that they were taking bids for the Broadway Dam Low Outlet repair on January 15, 1981 at 2:30. Council received as information and asked Mr. Simpson to report the results of the bids at the next Council meeting on January 20, 1981.

Mr. Clinton King requested the approval of a 50-50 grant to purchase a truck, tilt and 2 containers. He stated that the truck would not be delivered until after July 1, 1981 and the County's part would be approximately \$40,000 or \$43,000. On the motion

Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to approve the request for Solid Waste.

Mr. Watson reported on Revenue Sharing. He stated that we still do not know at this time what our entitlement amount would be, but we have been assured that the County will receive monies during January.

On the motion of Mr. Hooper, Council voted unanimously to adjourn at 9:35 a.m.
