**Sticks and Stones**



Bullying has become an increasingly dangerous aspect of daily life for some kids. Bullying is not an unpleasant rite of passage through childhood, but a life-changing experience for some. It has evolved with technology and is not just playground teasing anymore. I bet you can remember being bullied.

Sullivan's Island Elementary School takes bullying very seriously. The school is surpassing the local and state mandated Anti-Bullying policies to ensure their students do not become a statistic. Bullying starts in elementary school and gets progressively worse in middle school and potentially deadly in high school. Statistics show that about 160,000 children miss school every day out of fear of being bullied and some commit suicide as a result of bullying. This trend must stop!

Walker Russell, SIES's Guidance Counselor, along with Joy Harkins, SIES parent and founder of Peace-Pass It On, have teamed up for the 2<sup>nd</sup> year in a row to launch Peace-Pass It On, a nonprofit 501(c)(3) Anti-Bullying program. The program allows students to report bullying behavior in a safe and confidential manner. The programs reward system allows students to be recognized for acts of kindness toward others.

The program's mascot, Sully, is a one-clawed Low-country "red" blue crab with a peace sign on her shell. Sully is quite different and an easy target for bullying. Sully teaches children how to be a C.R.A.B. (Children Rallying Against Bullying) and how to T.R.A.P. a bully (Teach Respect And Peace). In addition to the Peace Program, Joy has written a collection of children's books. Her latest is called *Sully's Token of Peace*. Books may be purchased from the website, Island Time on IOP, and at Fordham Market in Beaufort, S.C.

**SC Medicaid agency announces improper release of beneficiary information**

**COLUMBIA, S.C.** — (April 19, 2012) During an agency performance review, the South Carolina Department of Health and Human Services (SCDHHS) discovered last week that an employee working within the Medicaid program inappropriately transferred personal information of 228,435 Medicaid beneficiaries to his personal email account, constituting a violation of agency policy.

The department discovered the transfers on Tuesday, April 10 and immediately contacted the South Carolina Law Enforcement Division to investigate the incident and also informed other state and federal agencies. The employee, who worked in Columbia, was terminated last week. It is not yet known why the individual sent the information to his personal email account but law enforcement is actively investigating. The transferred information was contained in 17 spreadsheets dating back to January 31, 2012 and included: names, phone numbers, addresses, birth dates and Medicaid ID numbers. Importantly, no private medical records or financial information was transmitted. In 22,604 of the cases, Medicare numbers, which contain Social Security numbers, were also linked to beneficiaries' names. More than 90% of the affected beneficiaries live in six counties: Allendale, Bamberg, Barnwell Lexington, Orangeburg and Richland.

"Our department is entrusted with personal information for hundreds of thousands of individuals, and it is our duty to secure that information," SCDHHS Director Anthony Keck said. "We are disappointed that one of our own would violate that trust and are deeply apologetic for not preventing the inappropriate release of this information." The agency is sending personal letters to all affected beneficiaries notifying them of this incident and explaining how to protect their information moving forward. Beneficiaries can also find more information at [www.myscdmedicaid.org](http://www.myscdmedicaid.org) and by calling 1-888-829-6561.

Although no health information was released, to address the possibility of identity theft and to give beneficiaries peace of mind, SCDHHS is making available a free year of identity protection services to every affected individual through Experian's ProtectMyID Alert. This service includes:

- A free credit report;
- Daily credit monitoring to detect any suspicious activity;
- A \$1 million identity theft insurance policy.

The public is urged to be aware of scams. Aside from the letter to affected beneficiaries, SCDHHS will never call or otherwise contact those affected asking for your personal information. Beneficiaries are advised to never give out their Social Security numbers or other identifying information to people they have not personally contacted. Since the transfers were discovered, SCDHHS has taken several steps to safeguard beneficiaries' personal information and strengthen agency policies and procedures, including:

- SCDHHS has created a website at [www.myscdmedicaid.org](http://www.myscdmedicaid.org) to answer questions from beneficiaries and help them enroll in the free protection services.
- SCDHHS has established a toll-free call center at 1-888-829-6561 for Medicaid beneficiaries to learn if their personal information was affected and to enroll in free protection services.

- SCDHHS is placing print and radio advertising throughout the state as well as reaching out to local organizations and the provider community to help make beneficiaries aware of the incident and the services available.
- All files and computers where this information may have been stored have been impounded by law enforcement.
- SCDHHS has frozen access to aggregate personally identifiable health information for much of its staff.
- Additionally, SCDHHS has hired an external IT security firm to conduct an external risk assessment of its data and IT systems security.

*Summit to feature former Florida Governor Jeb Bush as special guest speaker*

**Columbia, SC** – U.S. Senator Jim DeMint (R-S.C.) will partner with Governor Nikki Haley, Speaker of the House Bobby Harrell and SC Superintendent of Education Mick Zais to host the Empower South Carolina Education Reform Summit this Friday, April 27, 2012 in Columbia, SC. The event will begin with a lunch featuring former Florida Governor Jeb Bush, Founder of the Foundation for Excellence in Education, as the keynote speaker and will continue throughout the afternoon with various informational sessions and networking opportunities.

Attendees will join education policymakers and opinion leaders from around South Carolina and the nation to learn about important developments and best practices in education reform, grow South Carolina's network of education innovators and strategize on the path forward for empowering students.

The Empower Summit will be held at the Columbia Convention Center from 11:00 AM to 4:00 PM.

**SUGGESTED TALKING POINTS:**

- Too many politicians think that our commitment to education can only be measured in dollars, but I know that they're wrong. We already spend more per-student than many other Southeastern states, but too little of that money is making it into the classroom, where it can have a meaningful impact.
- When I prepared my Executive Budget for the upcoming fiscal year, my goal was to improve outcomes – to maximize the value of our investment in South Carolina's schools by focusing our spending and our efforts where they really make a difference.
- With this in mind, I had three overall priorities:
  - Quality and Innovation
  - Accountability
  - Effectiveness
- Quality and Innovation
  - Drawing from the recommendations of Superintendent Zais and the Education Oversight Committee, I recommended that we de-fund poorly performing programs and increase support for our Reading initiative and for educational technology.
  - I proposed \$10 million in additional support for our charter schools because parents and children deserve choice, and because charters are incubators for fresh ideas.

- I also recommended \$1.75 million for STEM Centers, plus \$2 million more to expand Teach for America into additional communities. If we're in search of better outcomes, then we have to be prepared to try out new approaches.
- Accountability
  - My budget also proposed that we transition to a model of Accountability-Based Funding for higher education – to pay South Carolina's public colleges and universities based upon the quality of their performance instead of the quality of their lobbying. The General Assembly hasn't acted on this proposal yet, but we'll continue to press for it.
  - At the K-12 level, if we're to hold educators and administrators accountable, then we need a comprehensible method of evaluating their performance. Superintendent Zais believes that we should transition to a simple letter-grade approach to rating our schools, and I agree with him.
- Effectiveness
  - Our schools are most effective when our resources are dedicated to instruction instead of administration.
  - Just a few days ago, I was pleased to sign legislation to consolidate Marion County's three school districts into one. This will reduce overhead costs and get dollars back into the classroom. I hope to see more bills like this one reach my desk in the next session.
  - I also continue to believe that privatizing our state-run bus fleet and introducing an element of local choice would let our state's Department of Education focus on the more critical task of teaching our children.

GE also has ancillary projects in SC that include: GE Medical in Florence (magnetic imaging devices) and Venture Aero Bearing, a joint venture in Charleston – a ball bearing plant that is joint with SKF bearings.

Last year GE was vying for the alternate engine, which is on the JSF35 joint strike fighter. Pratt & Whitney is the sole competitor. GE was lobbying in SC and to our Congressman to approve at the Congressional level, but it was defeated. One Upstate Congressman voted for Pratt & Whitney opposed to GE.

Another side note: The importance of the GE turbine facility and what a big deal it is was best illustrated by GE's commercial during the 2012 Super Bowl Game.
