Please note that you received the following notice on July 17, 2013 and are now past the due date for submitting your revised MIPPA budgets. Please provide this information today as instructed below:

MIPPA Grant Applicant:

ACL & CMS have collectively reviewed the MIPPA applications. Some eligible states did not apply for MIPPA funds, or did not apply for all 3 priority areas. As noted in the FOA (pg 6), the funding from the states that did not apply was redistributed to existing state applicants based on the MIPPA funding formula calculation.

Attached to this email is a revised funding chart that depicts the re-distribution of the excess funding to the States that have applied for this MIPPA grant. ACL and CMS are requesting that each applicant resubmit the following documentation no later than 3PM on **Monday, July 22, 2013**:

- 1) A revised SF-424a (Budget Information – Non-Construction Programs) that depicts the **entire new budget** broken out by cost categories; and
- 2) MS Word document that provides a budget narrative for the **additional funds only**.
