ALISHA HANNA, MY DAUGHTER...NICHOLAS' MOTHER DID RE-FILE IN APRIL. AS... SHE WAS TOLD THAT SHE WOULD HAVE TO RE-FILE FOR HIM AS ADULT... SHE DID. BACK IN APRIL ...IN FACT!!

WHEN I SENT YOU THE PREVIOUS LETTER I DID NOT HAVE THE CLAIM NUMBER...AS ALISHA HAD MOVED IN AUGUST AND NICHOLAS' FILE HAD GOTTEN MISS PLACED. I AM SENDING YOU A COPY OF THE LETTER ALISHA RECEIVED FROM DISABILITY EXAMINER, T. SNOWDEN...WITH THE CLAIM NUMBER ENCLOSED...

THE CHARLESTON SOCIAL SECURITY OFFICE IS CLAIMING THAT ALISHA NEVER FILED. I SUSPECT THERE ARE SERIOUS PROBLEMS IN THAT CHARLESTON SOCIAL SECURITY OFFICE....TOO MANY NON-CARING...INCOMPETENT PEOPLE. WHO WILL LIE TO YOU AND TELL YOU ANYTHING TO GET YOU OFF THE PHONE..AND PROMISE TO CALL YOU BACK..BUT NEVER...EVER DO...

ALSO FIND ENCLOSED ALISHA'S RECENT LETTER TO THAT OFFICE...TO MR. BONILLA.

I AM SORRY...BUT THIS IS UNEXCUSABLE....NICHOLAS HAS NOT RECEIVED ANY  
BENEFITS SINCE JULY..AND...AS I EXPLAINED IN MY PREVIOUS LETTER...HE  
DESPERATELY NEEDS THESE BENEFITS.

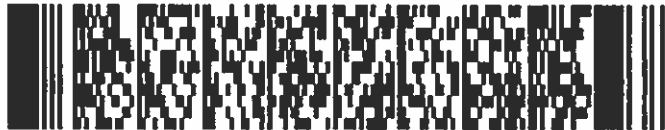

MY NAME IS ALISHA HANNA AND I RECEIVED A CALL FROM YOUR OFFICE BECAUSE OF A LETTER I HAD SENT TO YOU CONCERNING MY SON'S DISABILITY CLAIM. ENCLOSED IN THIS LETTER IS A COPY OF THE CLAIM NUMBER FROM THE SC BOARD OF DISABILITIES FROM A T. SNOWDEN WHOM I SPOKE TO VIA PHONE ONLY A FEW DAYS AFTER THIS LETTER WAS SENT. I FILED THE CLAIM FOR ADULT DISABILITY BENEFITS IN APRIL OF 2015. 3 WHOLE MONTHS BEFORE NICHOLAS' 18<sup>TH</sup> BIRTHDAY!!! WHEN I CALLED THE NATIONAL SOCIAL SECURITY NUMBER THEY FOUND MY SON'S INFORMATION AND TOLD ME TO CALL THE CHARLESTON OFFICE TO FIND OUT WHY I HAD NOT RECEIVED A LETTER FROM YOU SINCE THE FIELD WORK WAS FINISHED BY T. SNOWDEN. I WAS TRYING TO AVOID HIM HAVING TO WAIT SO LONG FOR THE ASSISTANCE THAT I KNEW HE WOULD NEED WHEN HE WAS NO LONGER ELIGIBLE FOR HIS FATHER'S SURVIVOR'S BENEFITS!!!!!! THIS LETTER PROVES THAT I AM NOT A LIAR WHICH I WAS MADE OUT TO BE BY YOUR OFFICE! YOUR OFFICE HAS COMPLETELY DROPPED THE BALL AND I HAVE COME TO THE CONCLUSION THAT IT IS BEING RUN BY INCOMPETENT PEOPLE WHO DO NOT WANT TO BE BOTHERED! I HAVE CONTACTED GOVERNOR HALEY'S OFFICE JUST AS I SAID I WOULD AND NOW I AM SENDING YOU THE PROOF THAT YOU NEED TO REALIZE YOUR MISTAKE AND MAKE IT RIGHT. MY SON HAS NO INCOME AND THIS IS A DISGRACE THAT HE HAS HAD TO WAIT 7 MONTHS JUST FOR YOU TO LOSE HIS APPLICATION!!!! I AM APPALLED AT THE WAY YOU TREAT PEOPLE WHO CANNOT HELP THEMSELVES AND I DEMAND AN EXPLANATION AS TO WHY HE WAS DISCARDED BY YOUR OFFICE. SOMEONE WILL BE HELD ACCOUNTABLE FOR WHAT HAS HAPPENED. I CAN ASSURE YOU THAT THIS IS NOT OVER AND SOMEONE IN YOUR OFFICE HAS SOME EXPLAINING TO DO.

I DO HAVE TO WORK SO I CANNOT JUST SIT BY MY PHONE BUT, IF YOU LEAVE ME A MESSAGE I WILL CALL YOU RIGHT BACK SINCE THERE IS NO MORE TIME TO WASTE. I EXPECT A CALL BACK AND NOT ANOTHER PROMISE THAT A SUPERVISOR WILL CALL. I AM STILL WAITING TO HEAR FROM THAT SUPERVISOR I MIGHT ADD.
