Linda,

No, but I looked at the bills.

S.69 will have some impact on DMV personnel, as courts would now have to start sending in conviction records for violations of selling alcohol to underage persons. This will have to come from DMV.

S.105 would make driving records show all DUI convictions over the past twenty years instead of ten. I am not sure that Phoenix is at all designed to handle that, so I would expect massive programming costs. In addition, a new batch of old records may have been left in Legacy that would now have to be brought over to Phoenix. Jimmy Earley and the people at Outlet Point will have to comment on this.

S.98 and H.3227 are almost identical and purport to allow DMV to privatize some of its functions. Since DMV would not do such a thing if it was going to lose money, there would not seem to be any impact. but, again, this is a statement that would need to come from DMV.
