Dear Mr. Pinson:

The South Carolina Department of Health and Human Services (SCDHHS) is in receipt of your yletter to Governor Nikki Haley concerning Centers for Medicare & Medicaid Services (CMS) Durable Medical Equipment, Prosthetics, Orthotics, and Supplier (DMEPOS) competitive bidding program. We welcome the opportunity to be of assistance.

This change to the CMS DME delivery system will impact those SCDHHS beneficiaries that are dually eligibly and Qualified Medicare Beneficiaries (QMBs) with Medicare as primary. For claims associated with these beneficiaries, the contracted provider has accepted the rates as outlined during the contracting process. SCDHHS will continue to adjudicate claims for these beneficiaries in the current manner, which is to reimburse the patient responsibility (co-pay and deductible) for services rendered. The Fee for Service (FFS) program will continue to utilize the fee schedule that is now in place for the products in the eight categories that were included in CMS Round 2 contracting.

It is the intent of Medicare to improve the effectiveness of its methodology for setting DMEPOS payment amounts, which will reduce beneficiary out of pocket expenses and save the Medicare program money while ensuring beneficiary access to quality items and services. In South Carolina, the three regions affected by this change are Charleston/North Charleston, Columbia, and Greenville/Mauldin-Easley.
