After a second review and seeing several comments, i would like to make the following suggestions:

- 1) We should start the recommendations with the vision and principles for the Task Force.
- 2) We should then state the overarching conclusions that we have reached such as the need for a Strategic Plan, Data Collection and on-going monitoring to confirm that we are making progress, and the need for a true comprehensive approach. There will be a significant need for additional funding over time.
- 3) Tom's comments that we focus too much on state agencies is on target. We need to emphasize that this is a statewide partnership effort and that we need to have government, private for-profit and non-profit organizations as well as volunteers to make our efforts work in providing long term care and support services for our citizens.
- 4) We definitely need data! We need to show at least some of the big picture pieces to help the Steering Committee and the Board make sense of the recommendations.
- 5) If we do this, then we can show the sub-committee recommendations with the understanding that they will be collapsed into a more coherent and streamlined final report.

I hope that these comments help us move forward.
