Christian is right. This issue involves Title X funds which are administered by DHEC.

Some new regulations went into effect on January 18, 2017 (under the Obama administration) which require that any Title X recipient (DHEC)

subawarding funds for the provision of Title X services not prohibit an entity from participating as a subrecipient for reasons other than its ability to provide Title X services.

H.J.Res.43 is a joint resolution which nullifies the new regulation. This means that it will be up to states to decide if abortion providers such as Planned Parenthood can access Title X funding.
