Social Security Hearing is pending Thanks to Senator Lindsey Graham
but my Attorney Harry Smithson is not providing the SSA the necessary
information citing 'other clients' and 'costs'. He has been mocking me over
my German heritage and and immigrant status- I came as a dependent of the
Armed forces and was a Permanent Resident of the US before I ever set foot
in the US; when I arrived in NEWARK NJ by AIRFORCE the AIRMEN saluted
and welcomed me; after 5years I was invited to become a citizen and obliged
which I had per contract as I worked for the US Government/VA and my husband
needed his top secret clearance back; I lost my German citizenship and took a
socioeconomic plunge moving to this country but I became a true American by heart
when my children were born much later- I had to divorce my husband who failed
to tell me he had a vasectomy I raised my two sons on my own and supported
their father for 20 years as well; anyways, my own lawyer dares to mock me because
of my heritage !!!

I call it a South Carolina Story made in Germany- I do not fit into the NARRATIVE
so I have no support: A white woman with olive skin an accent catholic with
a Jewish name accompanied by a Black man for
Gods sake and forbid she is a CONSERVATIVE!
My Olive skin comes from my greatgrand mother who was czech and the Nazis
harassed the family because of her- most of my sibs and kids are blond and blue..
I was a leftie like Barackie when I was a teen until Med School and my BF was
StudentSenator representing the foreign students and we travelled to Iracq after
I had just come back from peace mission to Israel – then I recognized how the lefties
where intolerant and my new conservative friends just the opposite- yes and I had travelled
to East Europe and seen what the commies where all about- I became a conservative.
I married an American- introduced by an Indian Ameican I said He doesn't look
too bad for an American turned out he was German born adopted by an
American Jew just after WW2 who married his mom true love and adopted all her kids
have so much love and respect for him named my son WILLIAM BLOCH after him
and we kept the family name after the divorce and definitely allied with ISRAEL FOREVER
told my Eastern Psychiatrist once that only Jewish doctors seem to treat me with respect\
because of my name – my father in law joked we were more Jweish then the rest
of the family
in spirit and even appearance ironically-he turned red and wanted to discharge me.

I get my independence back but you show up with a black man you are a NIGGER WHORE I cannot tell how many times HIV tests have been done without consent. My only lover since the father of my sons age 20 and 21 was an artist who never married Doug Shealy and whose mom died in the Bull street asylum . He told me to move back to Chapin there were too many Blacks in Columbia with my beautiful children I looked bewildered but I guess he tried to protect me from what I am going through.....


I think this would be an interesting story to share on the Internet- something to give people something to think about and with names being mentioned, to put shame on those deserving.
