And if Mr. Keck selectively allows certain flavors of SC Medicaid to set their own payment rates far below the standard rates (which are already some of the lowest in the nation), maybe we should talk to Mr. Keck, not the current host of insurance company CEO's who have millions of reasons to laugh at us all the way to the bank.

There are no bad people in this system, but this bad system is forcing physicians to send SC Medicaid patients (and SC Medicaid dollars) to your competition in Charlotte and Augusta.


