Mr. Poore recalled the meeting to order and Councilman David L. Hooper gave the invocation.

Mr. Kenyon presented Ordinance #90 (Kent, Inc. Project) for \$500,000 Industrial Development Bonds for first reading. On the motion of Mr. Kinley, seconded by Mr. Bratcher, Council voted unanimously to approve on first reading. Mr. Kenyon asked Council to approve Resolution #159 and Petition to the State Budget for Kent, Inc. Project. On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to approve Resolution #159.

Mr. Kenyon presented second reading of Ordinance #89 (Badische Corp.) for \$1,000,000 Industrial Development Bonds. On the motion of Mr. Kinley, seconded Mr. Bratcher, Council voted unanimously to approve Ordinance #89 on second reading.

Mr. Jean Taylor spoke on PATH. She stated that they no longer have the food program but the recreation portion of the program is still going on. Judge Dean spoke for the USDA Food Program. Council received as information.

Mr. Hooper presented Ordinance #91 (Human Resources Commission) for approval of first reading. On the motion of Mr. Rhodes, seconded by Mr. Kinley, Council voted unanimously to approve Ordinance #91 on first reading.

Mr. David Watson discussed the review of vehicle insurance. He stated that the only proposal made was by Wakefield, our present carrier and recommended that the County continue the insurance with Wakefield. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted to continue with Wakefield for the 1982-83 fiscal year.

Mr. Poore recognized Mr. Thad Arnold concerning the renovations of the Courthouse. Mr. Arnold discussed estimates for certain renovations in the Courthouse and the J.C. Penney Building.


1. To make the Whitner Building (J.C. Penney Building) look like the New Anderson County Office Building (Old Bailes Building) \$247,000

Mr. Kinley made a motion to instruct Russell & Axon to draw up detailed plans & specifications of the Judges Chambers, Circuit Judge, Jury Room, Judge Cox's Office, & bathrooms only, & to put out on bid and report back as soon as possible.

Mr. Wright amended the motion to include Master-in-equity & Probate Judge. Mr. Bratcher seconded the amendment, vote was 3 in favor, 2 opposed. Mr. Rhodes & Mr. Kinley voted against the amendment. Motion passed by majority. Going back to the original motion by Mr. Kinley, (as amended), Council voted four (4) in favor, and one (1) against. Mr. Kinley voted against the motion.

Council adjourned at 9:45 a.m.
