Dear Director Forkner:

It disturbs me greatly that our elderly population has to choose between, food, housing or the ability to secure their necessary prescription medicines.

Our constituent, Kathrynne Blair of Hopkins, falls into this category. Evidently, the SC Gap Assistance Pharmacy Program (GAPS) is reducing her benefits from 95 percent to 10 percent. This is a substantial reduction that she is forced to deal with.

Her monthly income stands at \$1158 which is reduced by \$96.40 for Medicare Part B, \$33.60 for Medicare Part D and \$215.30 for Medicare Supplemental which leaves her with roughly \$813 to live on. We all know how expensive it is now to purchase groceries; utility rates are constantly rising, all of the basics of living cost more. How is she supposed to purchase her medications?

Is there another program or additional prescription drug assistance that could possibly help her with these costs? I am afraid many senior citizens will fall victim to the reduction of the GAPS. Please review her situation to see if anything can be done for her.

Dear GAPS Beneficiary:

According to our records, you are enrolled in the South Carolina Gap Assistance Pharmacy Program for Seniors (GAPS). This program provides assistance to help with your Medicare Part D drug coverage.

Most people who join a Medicare Prescription Drug Plan, after paying a monthly premium, are responsible for 100% of their drug costs after total prescription costs reach a dollar amount determined by Medicare. For calendar year 2009 this amount is defined as \$2,700 to \$6,153.75. This gap in Medicare drug coverage is referred to as the "doughnut hole." The GAPS program provides assistance to help pay your drug costs when you reach the "doughnut hole". With the GAPS program, you were paying 5% of your prescription costs during this gap in Medicare drug coverage and the State of SC, under the GAPS program, was covering 95% of your costs.

Unfortunately, as a result of the South Carolina Budget Reduction Bill, the GAPS program must now limit these services. This letter is to inform you that beginning January 1, 2009, the part of your prescription costs covered through the GAPS program is being reduced from 95% to 10%.

How does this affect you?

This means that starting in January, if your prescription drug costs cause you to reach the Medicare Part D "doughnut hole", the GAPS program will pay 10% of your drug costs while you are experiencing the coverage gap.

For example: Once your drug costs reach the gap in your Medicare drug coverage, you currently pay \$5 (or 5%) for a prescription costing \$100. Beginning January 1, 2009, you will pay \$90 (or 90%) for a prescription costing \$100 once you reach the gap in your Medicare drug coverage.

How can I reduce my overall prescription drug costs?

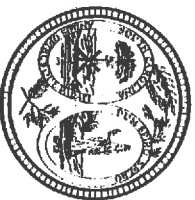
Choosing generic drugs is an excellent way to save money. Nearly 65% of all prescriptions are filled using generic alternatives. The next time your doctor writes you a prescription, ask if a generic version is available to help you save money. When you take your prescription to the drugstore, tell your pharmacist you would like a generic drug. Remember, when you use a generic drug, you get the same quality as the brand-name drug at a lower cost.

Additional information

It is important that you contact your drug plan to find out if they will continue to participate in GAPS in 2009. In order to benefit from GAPS, you must be enrolled in a plan that coordinates with the state's GAPS Program. If you need to change plans, call the new plan of your choice to enroll. If you need to find a new plan, call 1-888-549-0820 Monday - Friday between 7:00AM and 7:00 PM.

Thank you for contacting our agency on behalf of Kathrynne Blair regarding the recent changes in the Gap Assistance Pharmacy Program for Seniors (GAPS).

Determining which programs and services to reduce during such difficult times is always challenging. We deeply regret the recent changes to Medicaid and apologize for any stress or inconvenience these changes may have caused your constituent. A member of my staff has been in direct contact with Ms. Blair to address her concerns.

We informed Ms. Blair of Medicare's *Extra Help* low-income prescription drug program. If eligible, this program would cover the cost of her drug care premium, deductibles and leave only a small co-pay per prescription. Medicare's *Extra Help* program provides more coverage than GAPS. The Social Security Administration administers the *Extra Help* program and we provided Ms. Blair with their contact information to determine if she may be eligible.

We mailed her an application for the Qualified Individual (QI) program, which, if eligible, would pay her Medicare Part B monthly premium of \$96.40. The QI program is available on a first-come first-serve basis, so it is important that Ms. Blair return her application as soon as possible to be considered for the program. In South Carolina, QI beneficiaries are only eligible from January through December and must re-apply each year. In October each year, individuals currently eligible for the QI program will receive communication from our agency letting them know to reapply for this benefit in the next calendar year.

Thank you for your continued interest and support of the South Carolina Medicaid program. If I may be of further assistance on this or any other matter, please let me know.

Enclosed is a list of pharmaceutical drug companies that offer discounts on brand-name prescriptions to Medicare-enrolled individuals who meet certain eligibility guidelines and income limits. 
