

**ABBEVILLE COUNTY COUNCIL  
REGULAR MEETING  
JULY 10, 2006  
MINUTES**

**PRESENT:** Chairman Gunnells, Vice Chairman Simpson, Councilman Davis, Councilman Thomas, Councilman Calhoun, Councilman O'Quinn and Councilman Norris.

**CALL TO ORDER:**

Chairman Gunnells called the meeting to order at 7:30 p.m.

**PLEDGE OF ALLEGIANCE:**

Chairman Gunnells led the Pledge of Allegiance.

**INVOCATION:**

Councilman Thomas gave the invocation.

**FREEDOM OF INFORMATION ACT:**

Chairman Gunnells stated for the record that both the Press and Banner and the Index Journal were notified of the meeting and that the meeting was posted on County Buildings as required by the Freedom of Information Act.

**APPROVAL OF MINUTES:**

Councilman O'Quinn made a motion to approve the minutes of the June 26, 2006, regular county council meeting. Councilman Davis seconded the motion. The motion carried 6-0-0.

**PUBLIC COMMENT:** None

**PRESENTATIONS:**

Ms. Janet Vanderfer of the Mental Health Association in Abbeville County spoke with council on what their association hopes to achieve and asked for the County's assistance in obtaining office space of 450 square feet.

**OLD BUSINESS:**

- a) Third reading of an ordinance (06-10) to amend the Abbeville County Official Zoning Map for a 23 acre tract of land located near the intersection of S-1-125 and S-1-72 and identified by tax map number 064-00-00-033 from Forest/Agricultural (FA) to Restricted Residential (R-8). Vice Chairman Simpson made a motion to approve third reading. Councilman O'Quinn seconded the motion. The motion carried 6-0-0.
- b) Third reading of an ordinance (06-11) to amend the Abbeville County Official Zoning Map for a 12.5 acre tract of land located at 2121-2596 Hwy. 20 in Abbeville and identified by tax map numbers 070-00-00-104, 122, 068 and 130 from Light Industrial (LI) to Basic Industrial (BA). Councilman Norris made a motion to approve third reading. Vice Chairman Simpson seconded the motion. The motion carried 6-0-0.

Councilman Calhoun arrived for the meeting.

#### **NEW BUSINESS:**

- a) First Readings: New Policy – All first readings are read into the record by the Chairman, and a vote is not necessary.
- b) Resolutions:
  - 1) A resolution (06-41) authorizing the County Director to enter into a contractual relationship with Ray Walker Trucking Co., Inc., P.O. Box 469, Piedmont, SC 29673 for the purchase and hauling of stone products for use by the Abbeville County Department of Public Works. Councilman Davis made a motion to approve this resolution. Councilman Norris seconded the motion. The motion carried 7-0-0.

Councilman Thomas made a motion to add item #2 resolution 06-42. Councilman Norris seconded the motion. The motion carried 7-0-0.

- 2) A resolution (06-42) designating July 22, 2006, as Jesusfest day in Abbeville County. Councilman Thomas made a motion to approve this resolution. Councilman Norris seconded the motion. The motion carried 7-0-0.

There being no further items of discussion Vice Chairman Simpson made a motion to adjourn. Councilman Norris seconded the motion. The motion carried 7-0-0.


