Last year was the first year we had an event at the Statehouse. Before then, annual events had been held at various expo-type sites around town.

Overall, I think the event at the Statehouse last year was a nice change in venue, especially for those who had never had an opportunity to visit. We, of course, have a few things that we prefer to tweak this year (that were suggested at last year's event) to make the site easier to navigate for older adults. However, the one uncontrolled variable that we face at the Statehouse is weather. With sun and temperatures in the high 60s last year, we considered ourselves very fortunate. But, cold temperatures and/or rain could greatly impact turnout.

That being said, the Lieutenant Governor's role can be whatever you like. Using last year as an example, (then) Lieutenant Governor McMaster participated in a brief press conference in the Statehouse lobby; before lunch, he welcomed everyone at the tent outside before the food was blessed and lunch was served. **For reference, I have attached a condensed schedule of events from the event last year.**
