One hard copy set of the States standard Intel Inside price fix recovery complaint and one hard copy of my civil rights complaint to prove racketeering and government concealment in the Trump Administration pack. All States AGs, Governors, Senate and House representatives maintain copies or are aware of these case documents.

All other packs contain soft copy of Intel Inside® States boiler plate complaint of 2009 3rd revision with instructions with treatise addressing Intel Inside® bilateral contract agreement. My recent civil

right's complaint on denial 14th amendment right to validate a concerted action by coconspirators establishing retaliatory harms 18 USC §§ 1512, 1513 is also available on Pacer; USDC NCD-16-CV-80233-WHA. Here includes enclosed USB, knowing FBI/SS check requirement have someone check for storage virus. Being systematically stripped of my financial means by organized crime, as punishment to shut up, I could not afford to copy and post full set of aforementioned hard copies. House Oversight & Government Reform Committee in receipt of 18 year record of correspondence establishing system failure to address the matter; industry, law enforcement, federal government and the United States Senate misrepresentations and finger pointing about who should have done what.

On this transition letter, please find hard copy federal proofs my original witness source status includes 31 USC § 3729 federal false claims explicit contract. Note a federal judge in Northern California District is attempting to strip me of that contract, violates contract law ex post facto in a legislative act that also violates separation of powers. At 18 USC § 1001a (1)(2)(3) is engaged in consciously parallel concerted FCRP60b(3) fraud with defendant attorneys to block federal financial recovery and defendant penalties. Civil rights complaint all here are aware, see Pacer; USDC NCD-16-CV-80233-WHA *is cognizable and observing AGs know that* on continuing violations 1st and 14th Constitution guarantees to sue, prove slander, libel, witness tampering by Intel Corp. and ARM Inc. Addresses attorneys and Judges co-conspiratorial network conduct concealing harms on organized crime infiltration into Intel Corp. Where associate crime network chalks up 26 standing federal stature violations prior 23 years. Appears a novel form of economic espionage at 15 U.S.C §§ 1, 2 and 18 U.S.C. §§ 2, 3, 241, 242, 371, 641, 1001, 1341, 1503, 1505, 1510, 1511, 1512, 1513, 1516, 1519, 1956, 1957, 1961, 1962c, 1964c, 1831 & 2382 questions, 31 U.S.C. § 3729 theft from federal government.

Mr. Obama and Mr. Biden, I truly appreciate your providing President Elect Mr. Trump and Vice President Elect Mr. Pence this orientation moving the matters to United States Department of Justice antitrust, civil fraud and criminal address. My self working toward that goal for nearly two decades viewing my former employer's infiltrated and dismantled Intel Corp cartel crime forces, the industry robbed, thereafter on federal attorney recruitment in 1998 for Docket 9288 dodge assassination attempts and reject defendants ibansik programming regimes. Enlisted again in 2008, I still support FTC Docket 9341 today on cohort's reassigned, running away, or being hired by Intel law firms.

Advocating Congress hearing supporting situation assessment for antitrust law augments, new law legislation preventing another similar federally sponsored Intel monopoly experiment that is an inter nation financial economic failure on substantial inter nation theft. "The burst of administrative and organizational ingenuity is symptomatic of a fundamental aspect of the history of governmental involvement in scientific activities. The government's need for science *has frequently stimulated it to new organization and structural experiments*. The basic problem has been that much as the government needs science, science has, by and large, offered its services only on its own terms. Those terms have been support without control, or in other terms power without responsibility", Carroll Pursell Jr., Government and Industrial Technology, 1966. One half of Intel Corp's 23 year production revenue is unaccounted and non-reported on the FTC economic audit. Includes theft of EUV/Ebeam lithography risk capital savings development advance by PC distribution channels and that aspect of the crime should be addressed; not covered up. Otherwise, as required under federal law, I have to address the whole matter. That was not my federal assignment. I trusted the federal government to address this espionage *and not to cover it up*. Every nation in the world, aware, is watching this embarrassing domestic conundrum play out.


Subsequently, too pass proposed Congressional Intel Fraud;

Proposed Congressional Intel Fraud Act Defined – Meant to secure resolutions including law legislation on confirmation of statutory provisions here proposed **the Congressional Intel Fraud Act** punishes concealment and white wash over the investigative discoveries (15 U.S.C §§ 1, 2 and 18 U.S.C. §§ 2, 3, 4, 371, 641, 1001, 1341, 1503, 1505, 1510, 1511, 1512, 1513, 1516, 1519, 1956, 1957, 1961) *of any federal civic servant, including their discovery and academic studies aids*, by employees of any Federal agency, Presidential administration, members of Congress, judges and attorneys, Federal and States law enforcement personnel associated with intent to cover up, or conceal too negate address, by obstructing any U.S. citizen's report of industrial and economic espionage, RICO, associated trade and commerce violations occurring within the boundaries and jurisdiction of United States; punishable by life sentence no option of parole.
