Our Small Business here in NJ

Our planners have compiled some information that indicates that in total, (all affected States) that Hurricane Sandy negatively affected upwards of 75,000 small businesses. There forecast is that up to 30 percent of those companies will fail completely as a direct result of the this event.

In New Jersey, there are several small businesses that will not be reopening. In short, the cost or value lost from Business interruption will more than likely exceed the cost of damaged facilities here. We shall see. I hope this helped a little.
