For over 35 years NHSSF has promoted homeownership and neighborhood revitalization across South Florida's Miami-Dade and Broward counties. Through Partners in Progress (PIP), NHSSF is working with local organizations and agencies to advance the flow of resources in the 79th Street Corridor to build more affordable housing, grow employment, and generate an economic stimulus that will in turn support more neighborhood stability. NHSSF is also developing a transit node in the corridor that uses the current infrastructure of bus and rail lines to provide job access for residents and expand access to existing jobs in other parts of the South Florida region.
