M I N U T E S

PRESENT: Chairman - C. Edward Poore

Mr. Poore called the meeting to order and Councilman Curtis Kinley gave the invocation.

On the motion of Mr. Kinley, seconded Mr. Rhodes, Council voted unanimously to approve the minutes from the June 30 & July 6, 1982 meetings as mailed.

Mr. Kinley discussed a petition signed by approximately 87 residents of Greenbriar Subdivision asking that the subdivision be resurfaced. Mr. Kinley asked that Mr. Poore include Greenbriar to the list to be resurfaced.

Mr. Black asked that a portion of Chenault Road be closed. Mr. Poore recommended that the County Engineer check out the request. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to receive as information.

Mr. Watson read a letter from the Registration Board requesting an additional \$4,000 for the operation of the office. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to grant the request and to take the \$4,000 from the Contingency Fund (Account #910).

Mr. Watson discussed that in the past the County Physician (Acct. #414) had received the same increase as all other County Employees, but was omitted by mistake this year. The increase would be \$540 to bring the total of Account #414 11,340. On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to grant the request and to take the money from the Contingency Fund (Acct. 910).

Mr. Watson presented a request from the Health Department to purchase a duplicating machine from Harper Brothers for \$2368.37. On the motion of Mr. Bratcher, seconded by Mr. Wright, Council voted unanimously to approve the request.

Ms. Gladys Albert, Executive Director-Mentally Retarded Board, asked Council for permission to purchase gasoline from the County as done in the past. On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted unanimously to approve the request.

Mr. Galloway asked Council to reappoint Mr. Charles Gillespie, G.G. Galloway, Jack Huggins and Elsie Thompson to the Recreation Commission. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to approve the request.

Mr. Edgar L. Terry, representing the Anderson Community Federal Credit Union, asked Council for permission to provide the Credit Union facility to the County employees. On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted unanimously to allow Mr. Terry to contact each department to see if anyone would be interested, at no charge to the county.

Mr. David Crenshaw asked Council's approval to purchase radio equipment which is funded in the current budget for \$30,000. They requested to purchase from Motorola because they are the only manufacturer of this type of equipment. On the motion of Mr. Wright, seconded by Mr. Kinley, Council voted unanimously to approve the purchase.

Mr. Crenshaw asked approval of first reading of an ordinance to regulate the use of public parks in Anderson County. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to approve Ordinance #92 on first reading.

Mr. Karl Kenyon presented second reading of Ordinance #90 (Kent, Inc.) for \$500,000 Industrial Development Revenue Notes. On the motion of Mr. Kinley, seconded by Mr. Wright, Council voted unanimously to approve on second reading.

Mr. Kenyon asked approval of third and final reading of WPP for \$4,200,000 Industrial Revenue Bonds (ORDINANCE #87). On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to approve.

Mr. Kenyon presented Ordinance #89 for third and final reading for Badische. On the motion of Mr. Rhodes, seconded by Mr. Kinley, Council voted unanimously to approve on third reading.

Mr. Kenyon presented Ordinance #91 (Human Resources Commission) for second reading. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to approve.

Mr. Robert King discussed the loss of School Warning Receivers by burglary. To replace these two pieces of equipment it would cost \$366.00. On the motion of Mr. Hooper, seconded by Mr. Bratcher, Council voted unanimously to grant the request and to take the \$366.00 from the Contingency Fund (Acct. #910).

Mr. Rhodes presented Ordinance #93 (Nine Single Member Districts) calling for & scheduling a referendum to change the number of County Council single member districts for approval on first reading. On the motion of Mr. Rhodes, seconded by Mr. Kinley, Council voted unanimously to approve Ordinance #93 on first reading.

Mr. Rhodes asked that Ashley Downs be taken into the County system. He stated it passed all the requirements. On the motion of Mr. Rhodes, seconded by Mr. Hooper, Council voted unanimously to take into the County system.

Mr. Hooper presented second reading of Ordinance #88 (Change in Form of Government). On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted three (3) in favor and two opposed. Mr. Wright and Mr. Bratcher voted against the motion. This would be effective Jan. 1, 1983.

Mr. Carlisle Thompson asked Council if he could use the money appropriated for a full-time deputy on a part-time employee for Broadway Lake. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to allow the request.

Ms. Jean Taylor discussed the funding of PATH, Judge Dean discussed the support needed with the summer food program. Council received as information. Ms. Taylor will notify County Council of their next board meeting.

A concerned citizen asked Mr. Poore to patch potholes on Hurrican Creek Road and to cut weeds. Mr. Poore stated that he was doing all he could with the mowers he had.

Mr. Poore presented a list of roads to all Councilmen that needs to be resurfaced.

On the motion of Mr. Kinley, seconded by Mr. Rhodes, Council voted three in favor and two opposed to conduct an independent inventory of the County farm. This inventory to be conducted by Mr. W.M. "Red" Ashley, Paul Boiter and Lake Merdith.

County Council met with Mr. Thad Arnold concerning renovations of the Courthouse.

Council adjourned at 8:00 p.m.
