Hi Nicole:

On March 13, 2014, Governor Haley visited with me and Deloris Mungo at the Pawmetto Lifeline Adoption, Medical and Education Center.

One of the topics we discussed was a Bill that was introduced by the South Carolina Association of Veterinarians. The Bill restricts medical services by not for profits, says who we can serve and where we can offer services in an effort to protect the profits of private vets. Senator Verdin is the driving force behind the Bill and he and some of his committee members will tell you the purpose of the Bill is quality of care. Not for profit organizations around the state have agreed to all quality of care issues in Senate Bill 687 and ask that they remove all language that restricts trade.

We have even had a well respected anti trust lawyer speak before the Ag Sub Committee with little to no impact on Verdin's position or his committee's position. Much of what is being stated about our services, tax advantages of not for profits, etc is simply not correct.

When we met with Governor Haley she told us that she would not support the Vet Bill.

Would it be possible for us to have a meeting with Governor Haley to bring her up to date on the current status of the positions and discussions amongst the Senators. The Bill is now on the Senate Floor. Senator Joel Lourie is the current objector.
