SECTION 1: The Minutes for the meeting of October 17, 2001; copies of which had been previously mailed to each member of the Commission, were approved.

SECTION 2: On motion of Commissioner Mack, seconded by Commissioner Harrell, the Commission unanimously passed a motion excusing the absence of Commissioner Stoddard due to illness.

SECTION 3: The Commission unanimously passed a motion accepting a report by the Department of contract #155, modification #9, PIN #21705, File #15.627, Colleton County, as shown in detail in the Appendix.

SECTION 4: The Commission unanimously passed a motion approving contract modification #2601-2001, Pin #26006, Project #39, Pickens County, as shown in detail in the Appendix.

CONTRACT MODIFICATION

Contract No. 155 - Modification No. 9
PIN 21705 , File 15.627
I-95 - Rest Area Improvements - Colleton County

The Department has entered into a contract with Arcadis, Geraghty and Miller, Incorporated to provide professional services for the rest area buildings on I-95 in Colleton County.

This work consists of the design of and the construction phase services for emergency back-up generators for both rest areas with the associated sewage pump stations and the intermediate sewage pump station for a complete emergency system. The cost of the contract is \$17,235.00. The funding for this project comes from Interstate Maintenance Funds.

The Department does not have the expertise or specialized manpower to provide these services; therefore, consultant services are being used. The Basic Agreement for this project was executed on 6/1/99.

Executive Summary – July, 2000

Contract Modification 2601-2001, PIN # 26006, Project # 39,
Interchange at US-123 and S-53
Pickens County, South Carolina

The Department has entered into Contract Modification 2601-2001 with PBS&J to perform the hydrologic and hydraulic analysis for the above described project. The cost of this Contract Modification is \$40,433.86 Funding for this project is from Pickens County. This is the first Contract Modification for this project.

This contract modification comes under the original agreement that was approved by the Commission on July 30, 1998.

“On Call” Geotechnical Materials Testing and Inspection

The South Carolina Department of Transportation (SCDOT) requests Commission approval to advertise and select consultant(s) to provide testing and inspection of Geotechnical materials on an “on call” basis. The contract will be for a period not to exceed three (3) years. Services will be provided for statewide projects. The funding source will be both State and Federal.

EXTENSION OF CONSTRUCTION CONTRACTS

It is recommended that the Commission approve the action of the Department in extending existing construction contracts to include additional work, as follows:

Estimated Cost of Extension \$ 8,701.30

Contract of Weaver Company, Inc. - File 26.991 - extended to include an additional section of Project SIB-GSLA (013) (File No. 26.991) consisting of the installation of a sidewalk on SC 544.

Estimated Cost of Extension \$ 52,592.00

SUMTER COUNTY:

Contract of Rea Construction Company - File No. 43.116B - extended to include an additional section of Project C-116B (File No. 43.116B) consisting of the resurfacing of Road S-102, S-33 and S-490 for a total of 0.77 mile.

Proposed rule addition for the MPO/ COG bonding program

Issue: The Low Country Council of Governments has requested that the SCDOT Commission consider allowing an MPO or COG the option to expand their bonded program. The Current bonding program rules do not allow for additional projects to be added to the program.

Background: Presently several MPO and COG programs have accumulated sizeable cost under-runs. Because of the cost under-runs these MPO and COG programs have an opportunity to expand their current list of projects or expand scope on an existing bonded project. The existing rules, which are attached, currently do not allow for an MPO or COG to add an additional project or change the project scope.

The cost under-runs occurred because of a variety of factors. Several projects are under-running the original budget due to favorable construction bids. Also the department has implemented cost saving measures on several projects to realize savings.

Recommendation: The following is a proposed rule to be added to the current MPO / COG bonding rules:

An MPO or COG may request the Highway Commission and SCDOT to adjust their bonding program at the point that approximately 75% of the construction program budget is under contract for construction. Adjustments may be made when a mutual agreement has been reached between the MPO or COG and SCDOT. All adjustments must follow the federal project development standards and they must stay within debt service limitations as defined in the intergovernmental agreement and are in accord with all other bonding rules.
