In advance of this week, below are brief summaries of the two refugee bills that will be in Senate Judiciary:

S. 928 - Bryant, Peeler, Fair, Bright

- requires all SC agencies to "immediately cease any involvement" with refugees placed in SC under the federal refugee program until the State Department has "reexamined the security concerns and established new processes for accepting refugees."

- prohibits SC agencies from accepting or aiding "in the acceptance of any new refugees" until the State Department has "reexamined the security concerns and established new processes for accepting refugees."

- requires SLED to confirm that refugees placed in SC do not pose a safety risk, and report to the GA its findings as soon as possible"

NOTE: would need to do more research, but there could be negative legal implications if the State pulls out of the refugee agreement it has with the Feds halfway through the year (we entered into the current agreement in August 2015). The better approach would be for us to just not enter into a new agreement next year.

S. 997 - Bright, S. Martin, Peeler, Fair, Grooms, Corbin

- requires refugees placed in SC to register with DSS w/in 30 days of entering the state.

- lists the information that must be registered with DSS (name, address, telephone number, job status, any state and/or federal aid they receive, etc.) and requires that information be updated w/in 10 days of it changing.

- requires DSS to make this information publicly available online.

- establishes a private right of action against a resettlement agency and its directors if a refugee from a State Sponsor of Terrorism country causes death/injury to, or destroys/steals the property of, a person that provided sponsorship or resettlement services to the refugee.

- prohibits state/local funds from being used directly or indirectly to benefit a refugee placed in SC.

NOTE: would need to do more research, but beyond the bad policy of putting refugee's PII online, it may be illegal for a state to require this type of registration and public disclosure.
