Delbert,

Attached is what we have been able to assemble in response to your request. Unfortunately, projects do not necessarily have a direct correlation with the financings and over time, as construction is completed, the data we have available on our systems tends to drop off and as a result, we lose its association. This is one of the limitations we are addressing in designing a new debt management system.

The debt data is completely accurate, but because of the limitations described above, the project data is unfortunately only indicative by type of debt, and may not be as comprehensive. Given more time, we can reconstruct it if it is needed.
