Small on the radar, but I want to float this up to you for your visibility.

I hope all is well in the Governor's Office.

A few calls from Charlotte media about the Escapee from Mid-May. He was captured in NC on 6/1 and is awaiting extradition to Columbia P.D. on separate charges. I have been careful due to he is in NC custody and CPD is in the process of extradition.

Encapsulated information from DJJ Inspector General:

Captured on 6-1-16 in Charlotte, NC by SLED. He was wanted by Columbia Police Department and they had him in NCIC before our warrant for Escape was entered; therefore they will have first dibs on him. Once he is returned to SC he will have a bond hearing on CPD charges. If he makes bond, they will notify us to come and serve our warrant on him for Escape, then he will have another bond hearing.

He is still in Charlotte awaiting extradition.
