At that time, we will be working together to prepare a list of recommendations to be presented to the LTC Taskforce Steering Committee at its meeting later next month. November 4 Meeting Date/Time/Logistics

- Date/Time: Tuesday, November 4 from 1:30pm to 4:00pm
- Location: The IMPH offices are located in the Tower at Gervais, which is the 20-story brown building at 1301 Gervais Street (one block from the SC State House between Sumter and Marion Streets). This is the same building where IT-oLogy and Bank of America are located. We will meet in the conference room on the first floor of our building.
- Parking: You can park in the Keenan Garage that can be entered from Marion Street at the side of the building. (Or, as another option, you can park in the Tower Garage that can be entered from Gervais Street at the front of the building. Visitor parking is on level 3. If all visitor spaces are taken, visitors may park in any space on any higher level of the garage that is not marked “Reserved.”)
