South Carolina Celebrates "Recovery Month"

COLUMBIA, S.C. – Governor Nikki Haley has proclaimed September as *Recovery Month* in South Carolina. (See *attached proclamation*.) During the month of September, communities statewide are encouraged to recognize the achievement of those who seek to overcome the stigma of addiction and secure the benefits of substance abuse treatment and recovery.

The theme of this year's *Recovery Month* in South Carolina is "Our Families, Our Stories, Our Recovery!"

"Educating our communities about how substance use disorders affect all people is essential to combating stigma and resolving misconceptions associated with addiction," Gov. Haley stated in her proclamation. "The mission of *Recovery Month* is to celebrate individuals who have achieved long-term recovery; to acknowledge those who work in the prevention, treatment and recovery services; and to encourage individuals and families in need to seek help."

"Thousands of South Carolinians are living in recovery from substance use disorders, and thousands more are striving to reach this goal," said Sara Goldsby, Acting Director of the S.C. Department of Alcohol and Other Drug Abuse Services (DAODAS). "Every day, individuals, families and communities take many different paths to wellness from the disease of addiction. It's important that we collectively honor and celebrate each journey."

To help celebrate *Recovery Month*, chapters of Faces and Voices of Recovery South Carolina (FAVOR SC) and other organizations are planning awareness events in cities around the state, including:
