- > William M. Blume, Jr., CPA, is the Executive Director of the South Carolina Public Employee Benefit Authority (PEBA). He was appointed to this position effective July 2012. PEBA is responsible for the administration and management of the state's employee insurance programs and retirement systems. As Executive Director of PEBA, Bill reports to an 11-member PEBA Board of Directors.
- > Prior to his appointment to the position of Division Director of the South Carolina Retirement Systems March 23, 2011, Bill was a retired Senior Tax Partner at Ernst & Young, LLP.
- > At Ernst & Young, LLP, Bill was Tax Partner-in-Charge of the firm's Retail, Manufacturing and Distribution Industries Tax Practice for the Southeast Area; Director of the Southeast Area Tax Accounting and Risk Advisory Services; and served as World-Wide Tax Services Partner for the Coca-Cola Company, Georgia-Pacific Corporation, the InterContinental Hotels Group, and Equifax, Inc. His leadership roles include management of the Geographic Area Practice as Director of Tax for the Florida Area and as Director of Real Estate Services at Ernst & Young's Denver office, as well as service on the Natural Resources Committee, and the firm's National Tax Process Improvement Committee and numerous other firm committees.
- > Bill taught courses at Ernst & Young, LLP, in addition to serving as an adjunct professor at the University of Miami Graduate School of Business and the University of Denver Law School. He is a member of the American Institute of Certified Public Accountants (AICPA) and served on various national committees for the AICPA. Bill also serves on the Board of Trustees of the Southern Federal Tax Institute, where he was past President and Chairman, and is currently Treasurer.
- > A native of Charleston, South Carolina, Bill earned a Bachelor's degree in Economics from Presbyterian College in 1970. He earned a Master's of Accountancy degree from the University of South Carolina in 1974 and a Master's of Taxation degree from the University of Denver Law School in 1980. Bill earned his certified public accountant (CPA) accreditation in 1978.

DOR) during an afternoon news conference at the Statehouse in Columbia. > The governor also encouraged the Internal Revenue Service (IRS) to require all states to have stronger security measures in place for handling tax information. A copy of the governor's letter to the IRS is attached.
