Please allow me to introduce myself. I am Laura Fowler and I have been the administrator for Kingston Nursing Center since 1992. We are honored to have been awarded CMP grant money in the past for our culture change activities.

Our leadership team met to discuss this most recent round of grants. We presently are unable to purchase any capital items such as a bladder scanner unless the entire amount is covered by the grant, which apparently it will not be. We already have an electronic record system in place and thus, can not use the grant money for that area. We also already utilize a company for resident satisfaction in conjunction with our parent hospital, and we are unable to change vendors at this point in time.
