Again if the town owns the building and land and Tom Peebles was Mayor at that time and Steve Riley was the town manager and still is , What do they know about this ???????? We need to see all on this attempted abuse and more. Even if records have disappeared certainly the secret Estimator is still alive and has records on how he arrived at 600.00 per sq ft .
