Dear Congressman Joe Wilson:

I am writing as a concerned parent. My daughter, Destiny Berry is a special needs child. She was born prematurely and is disabled. She has been through about 18 surgeries. In the summer of last year she started having numerous kidney infections, and finally in September we were diagnosed as having kidney reflux. The doctor decided that at that point we would try treating her with nightly antibiotics to keep the infections at bay. This did not work. She has had at least 7 infections since, that have been very severe requiring IV antibiotics and fluids to keep her hydrated. We followed up with our Urologist recently, who confirmed that with the number of infections she has been having that we should probably go ahead and surgically correct the problem. Here, is where my problem comes in. The surgery she needs is called Deflux. There are two options to fixing this problem. The first surgery is a pretty risky one, where they have to make a very large incision in the belly, it is roughly a three hour surgery, a three day hospital stay, and a 6 week recovery. The second option is a telescope procedure that is done in outpatient surgery, takes about 5 minutes and has a 90 % success rate. Of course I prefer the telescope procedure, but Medicaid refuses to pay for this procedure. I know it must be much cheaper the second way, and can't quite understand why we would do such a risky surgery when the second works just as well. I cannot afford to pay out of pocket for this procedure, but I also cannot afford for my daughter to have kidney damage due to these infections. This disturbs me much, as she has had 6 operations on the belly already, and every time we have to have a big operation as such there are lots of risks involved. The doctor said that they have been fighting Medicaid for some time now trying to get them to cover the costs of this procedure with medical evidence backing them up but with no avail. For now they are treating her with a much stronger antibiotic, and we are due for a kidney ultrasound in July to make sure that the kidneys are functioning properly. I would really like to make a difference in this, as I know that my daughter can't possibly be the only one needing this operation, and I know that I am not the only parent who does not want to put my child

through such a traumatic surgery. I feel that something should be done about this, and I have to make a stand for my daughters well being. I also know though that one voice does not make a huge difference, and anything that you could do to help us with this would be greatly appreciated. I have also contacted the local news to see if there was anything that they can do to help. Thanks for taking the time to listen to my concerns.
