Lillian,

First let me say it was a pleasure finally meeting you the other day and I look forward to working together to make South Carolina a better place for the Children of this state.

I am anticipating the outcome of the Messenger Case in the morning. I have done some additional research on this and this one just will not get out of my head. Something is just not right about this. It is my understanding that Mrs. Messenger is allowed to see her daughter 2 hours – once or twice a week and the little girl is left screaming and crying begging for her Mom or family at every meeting, grabbing and trying to hang on and that the case worker Ms. Carr is cold and rude to Mrs. Messenger, who we all know is suffering from stage 3 cancer. I also understand that Amelia who was placed in a Foster Home in another school district, rides the school bus when she was always taken to school by car and is now being called Kelly. She was placed in a family of another race and is no longer allowed to wash her hair regularly because of the culture difference and has sores in her head. I also understand there are other children in the home who do not get along well with Amelia, who already suffered from separation anxiety from her

family. What the State of South Carolina is doing to this child is abuse. There are family members who are willing and able to take care of this little girl if it is found that her immediately family is not capability, which I am seriously beginning to doubt because the credibility of the way the report was handled by Ms. Dubose.

If I did not have 3 meetings in the morning I would make the trip to Berkley myself to sit in on the hearing and if there is anyway I can find to make myself available I am going to be there. I am personally worried about the welfare of this little girl. I pray that the right outcome happens tomorrow.
