Her office says the event serves as a one-stop where people can find out about resources available to families and businesses to aid recovery. Representatives will be on-hand to help people register for financial assistance from FEMA, apply for disaster loans from the U.S. Small Business Administration and learn about repairing their homes. The event runs from 11 a.m. to 3 p.m. at the Marion County Administrative Building. There will also be information about applying for unemployment benefits as well as help from the Department of Social Services.

The State: Recreation board refuses Haley's request for sexual harassment report

A document that could provide crucial evidence on whether board members governing the Richland County Recreation Commission have grossly mismanaged commission affairs and personnel is being withheld from Gov. Nikki Haley. Board members made the decision to keep the document secret from the governor in a three-minute special public meeting Thursday evening at the commission's Adult Activity Center on Parklane Road. But first, they met out of public view in a small conference room

near the larger room. However, the commission did vote to turn over some 500 pages of documents the governor requested in an Oct. 19 letter to commissioners. The documents will be delivered to Haley's State House office Friday morning. Haley is trying to decide whether to fire five of the seven board members, including board chair J. Marie Green. Haley requested the report allegedly detailing the results of an internal sexual harassment investigation – as well as other information – to help her decide what to do.

The Richland County Recreation Commission will be handing over requested documents to the Governor's office, however, they are refusing to hand over a key report. Thursday night's special meeting with the board followed a request from Governor Nikki Haley. The request was for a variety of documents from the Commission, including the results of an internal sexual harassment investigation, that could help the governor's office respond to demands from most members of the county's legislative delegation who want Haley to remove five Commission board members. Thursday night, the board decided it will hand over documents, however, the sexual harassment investigation results will not be included. Senator Joel Lourie issued a statement, saying, "The actions tonight are again a blatant example of why this board needs to be removed. They are holding back information and covering for themselves and their former director. The people of Richland County deserve full transparency and accountability and with this board, they have neither. I hope the Governor will respond appropriately and put an end to this craziness."

The Richland County Recreation Commission will not share the internal investigative report into the commission and its former executive director with Governor Nikki Haley. On Thursday the board of commissioners who oversee the commission met for a special called meeting. Within five minutes the group adjourned. In that time they voted to approve the information compiled by the commission's staff and to give that information to Governor Haley on October 28. On October 19 the Governor wrote to the commission and asked for more information as she considers a request by legislators to remove several of the board members from their positions. She specifically asked for additional documentation about how they handled harassment claims, potential nepotism, allegations of intimidation and the Executive Director James Brown III's salary.

South Carolina Gov. Nikki Haley is reaffirming her support for Donald Trump, vowing to vote for the GOP nominee despite his attacks on her earlier this year. "That doesn't mean it's an easy vote," Haley, a Republican, said at a news conference on Wednesday. Authorities are urging residents in North Myrtle Beach to be wary of scammers who claim to be part of the Federal Emergency Management Agency and offer to help remove debris in the wake of Hurricane Matthew. The North Myrtle Beach Department of Public Safety wrote on its official Facebook page Wednesday that a black pickup truck bearing a sign that read "FEMA" was seen traveling through neighborhoods in the north end of the city. Officials say the truck's occupants were telling residents they would remove hurricane debris for \$1,500. Officials say FEMA personnel do not operate in this manner. Anyone who sees the truck is asked to record its license plate number and call police at 843-280-5511.

She walks stiffly from the debris pile to the electric line connection torn from the wall, rubbing her hands fretfully as she talks. "They came by my house today to pick up leaves, took a look and said, 'We'll be back tomorrow,' " Ann Lowther said, trying to grin about it. When a tree fell on her house during Hurricane Matthew three weeks ago, it poked holes through the roof and collapsed the siding like a ladder, compounding the mess. Lowther is 70 years old and arthritic. Her husband died two years ago. Her insurance has too high a deductible to meet and she just can't do everything anymore, she said. The Hanahan resident is one of more than 900 Berkeley County residents who registered for Federal Emergency Management Agency assistance by Wednesday, the day after the county was made eligible. By Thursday, more than 3,850 people were registered across Berkeley, Charleston and Dorchester counties. In eligible coastal counties across the state, the number was 29,359.

"I'm salvaging what I can, but I'm at the point right now where it hurts. It hurts real bad and, you know, we have to start over again. It's hard," said Linda June Cancer. Tears welled up in her eyes as she looked at some of the furniture she had just made her last payment on now heaped in a pile of soggy debris outside her home on Rosewood Drive. Dozens of residents in Rosewood Estates were tossing out furniture, tearing up floors and ripping out walls in homes that were inundated with flood waters for days after Hurricane Matthew struck. Cancer had lived in the home for two years. The historic floods of October 2015 pushed water to her house, but the flood water didn't come inside. "It came in this time," she said. "You can't imagine and I'm just a renter. Half of these people out here, they have to live with this. I don't. ... I can move." That's what she planned to do as she and others cleaned out the house that had once been home.

Hurricane Matthew downed thousands of trees in the city of Florence, many of which remain piled in yards, along roadways and sidewalks, and residents are wondering how long it will take to clean up. On Thursday, city officials announced their plan to tackle the more than 150,000 cubic yards of debris in the city, with a goal of returning to a normal schedule by the start of 2017. They have divided the city into six sections, four of which will be handled by contracted debris cleanup crews. Officials say cleanup should be in full swing by mid-November. "In the areas that have the largest amount of debris, we're going to use contract work for those areas," said City Manager Drew Griffin. "We're trying to get bid proposals out by [Friday] or Monday, and give contractors about two weeks to submit a bid, then we will choose a contractor or multiple contractors." Griffin said city debris crews have been running routes but the sheer volume of debris—about four years' worth of normal waste—is too much to handle.

Following Hurricane Matthew, Huntington Beach State Park personnel have been removing debris and repairing minor damage throughout the park in anticipation of the park's reopening Oct. 28. State Park officials said HBSP was closed when Gov. Nikki Haley issued a Zone A evacuation Oct. 6, and the park has remained closed for damage assessment and repairs. "Everyone was safely removed from the park after the governor issued her evacuation order," South Carolina State Park Director of Corporate Communications Dawn Dawson-House said. "There was some beach erosion along the jetties, and we are having to shore up the causeway because it was impassable. We had quite a bit

of debris along the beach, as well as throughout the park, and we also had to make a few minor repairs."HBSP Manager Brenda Magers said the majority of the damage within in the park occurred when the salt marsh overflowed at the causeway, causing erosion under the road and on the causeway sidewalks.

South Strand News: Pawleys Island totaling beach restoration costs

In the three weeks since Hurricane Matthew ravaged Pawleys Island, the town has spent more than \$230,000 on cleanup and beach restoration. Town Council approved paying R.E. Goodson Construction \$230,170 for its work so far at an emergency council meeting on Thursday evening. R.E. Goodson, which scraped the town's beach to restore the dunes after Hurricane Joaquin in October of 2015, began cleanup work even before the island was reopened to property owners. The company was brought in to help the National Guard clear Springs Avenue, which was covered with several feet of sand and left impassable after the storm. The National Guard did not have equipment large enough for the work, but R.E. Goodson did. "They really expedited getting folks back into their homes," Mayor Bill Otis Jr. said. R.E. Goodson billed the town \$46,500 for the Spring Street work.

Lancaster News: Duke Energy donates \$100,000 to hurricane-relief efforts in S.C.

They say it will take crews some time to get it all because they have to strictly follow FEMA guidelines. "We want to make sure that we get full reimbursement for FEMA, because our match is 25 percent of that amount, and that means that's half a million dollars," Griffin said. For the clean-up, the city has been divided into six zones. Starting Monday, crews will begin cleaning Zones 1 and 6. They will start working on Zones 2 through 5 after a contractor bid is accepted. Officials said they're expecting that bid to go out by Monday at the latest.

A judge on Friday might take up a First Amendment lawyer's request to reveal details of closed-door testimony last week in the Michael Slager case, along with a defense motion to have the former officer's charge dismissed altogether. The hearing, scheduled for 10 a.m., is the last chance for attorneys in the case to bring up legal issues before the trial starts Monday with jury selection. The presiding judge, Clifton Newman, also will listen to arguments from an attorney for The Post and Courier, whose objection to his closure of prosecutors' testimony last week had gone unheard. Slager, 34, a former North Charleston patrolman, is charged with a state murder count in 50-year-old Walter Scott's shooting death, which was filmed by a witness. He also faces three charges, including a civil rights violation, in federal court. Slager has insisted that he got into a fight with Scott after the April 2015 traffic stop and that the motorist snatched his Taser and turned it against him. He fired in self-defense, he said, as Scott turned away. The bystander's video showed Scott running when Slager fired eight shots, hitting him five times from behind.

Associated Press: Ethics Commission reprimands state treasurer for 2011 hire

The State Ethics Commission says state Treasurer Curtis Loftis violated ethics law when he helped in hiring a long-time friend to represent his office in a lawsuit against the Bank of New York. In an order released Thursday, commissioners publicly reprimanded Loftis and told him to pay \$500. Loftis says he will appeal the decision. His critics have long questioned a 2013 settlement of \$9 million to the state's two contracted attorneys. Of that, \$2 million went to Michael Montgomery, who Loftis helped bring aboard soon after taking office in 2011. Beyond being a long-time friend, Montgomery was a board member of a charity Loftis founded. The commission found that violated state law barring public officials from using their position to economically benefit an associate, even if it was unintentional.

Loftis and Montgomery served on the Board of Trustees of the Saluda Charitable Foundation together, a connection the ethics panel said created the conflict. "It is undisputed that the decision to hire Montgomery was a governmental decision and Montgomery had an economic interest in his retention as special counsel for the state treasurer," Regina Hollins Lewis,

chair of the ethics hearing panel, wrote.

State ethics officials reprimanded State Treasurer Curtis Loftis but didn't fine him for helping steer \$2 million in legal work to a longtime friend. Public officials "should err on the side of disclosure" when their actions made raise questions about "the appearance of impropriety," the decision by the State Ethics Commission said. Loftis contended that his failure to do that was inadvertent instead of intentional, according to the decision. The decision followed a private review by the panel after Loftis, who campaigned on opening more of state government to scrutiny, did not ask that it be conducted publicly. Leaders of a state retiree group questioned a hiring that they said cost their members \$2 million in legal fees paid as part of a settlement of a dispute with a bank.

Gun-rights and gun-reform advocates expressed their frustrations during the final of four meetings of the Senate's Gun Issues Special Committee, which has traveled the state taking testimony from citizens to determine if the state's gun laws should be reformed. "All this is, is a feel good law," Gerald Stoudemire, president of Gun Owners of South Carolina, told The Post and Courier about the effort. "What they're trying to introduce will do nothing to prevent crime," he added. "It will do nothing to deter the mass murders we had in Charleston and other areas." Many reform advocates have focused on the errant background check process that allowed accused Emanuel AME Church shooter Dylann Roof to buy a pistol two months before nine worshipers inside the church were gunned down during Bible study last year in Charleston.

South Carolina legislators have put the brakes on requests to "fast-track" repairs to two beach-front parks ravaged by Hurricane Matthew, saying the state's tourism agency needs a plan addressing all its parks. A legislative panel this week approved the engineering phase of rebuilding Edisto Beach and Hunting Island parks, located in Colleton and Beaufort counties, respectively. The Department of Parks, Recreation and Tourism wanted permission for the entire construction process, estimated to cost \$3.5 million combined, with federal emergency aid covering 75 percent. But lawmakers want to

make sure parks in their districts get attention, too. Rep. Murrell Smith, R-Sumter, noted Poinsett State Park near Wedgefield was also damaged. "While we do have to prioritize parks that attract the most people," he said, Poinsett brings tourists to Sumter County, and the agency should take advantage of the 75 percent federal match to fix whatever parks are eligible.

David Miller was looking in a rural Warrenton trailer park for a murder-trial witness when he saw something sickening. A dog was chained to a thick tree. The chain allowed the animal to move just a few feet in every direction. Left on its own — for who knows how long — the dog had taken to running in circles. As the dog ran around the tree, the chain had cut several inches into its wood on all sides. "There's absolutely nothing illegal about that in South Carolina," Miller, a deputy solicitor in the 2nd Judicial Circuit, told a panel of S.C. officials on Thursday. "My investigator said we ought to call animal control about that. They can't do anything about it." Miller's suggested Thursday that lawmakers should create a state tethering law, adding to a growing list of ideas pitched to the panel, tasked with studying how to improve pet care in the Palmetto State. State Rep. Steve Moss, R-Cherokee, who sits on the committee, said the need for solutions has been highlighted by the state's unflattering position in recent rankings. In 2015, South Carolina ranked 44th in the country in the Humane Society of the United States' annual survey of animal-welfare policies.

South Carolinians will see a bump in their paychecks but smaller tax refunds under a policy change that kicks in next year. The S.C. Department of Revenue is revising the way it calculates how much employers should withhold for income taxes, an update that will wind up putting \$1 billion back into taxpayers' checks over the next decade. The goal is to reduce the amount of money the state returns in tax refunds each year by taking out less money in the first place. Agency director Rick Reames says the change is long-overdue. In essence, the state's tax withholding requirements didn't change year-to-year, so while South Carolinians' tax bills changed with inflation, the amount coming from their paychecks didn't. Over time, the two got out of sync, and the state started taking in more than it was owed - an amount that has grown larger each year. So for the first time in 25 years, the department is updating the tables that dictate how much employers need to withhold. They'll be phased in over the next 10 years, starting in January. The tables will be updated annually.

The new drought map, voted on Wednesday by the state's drought response committee made up of multiple local and state agencies, shows a dividing line that virtually splits the state in two between the dry Upstate and the wet Midlands and Lowcountry. The Upstate's three westernmost counties — Anderson, Pickens and Oconee — were upgraded to severe drought status, a step below the highest designation of extreme drought. The rest of the Upstate was placed into moderate drought status.

The personal finance website WalletHub.com announced last week the findings of a recent research project that found South Carolina resting near the bottom of the list. In the report, WalletHub said, "Energy is expensive. It's one of the biggest household expenses for American consumers, who, on average, spend nearly \$2,000 per year on energy bills. About half of that amount pays just for heating and cooling." The report looked at 48 states, citing a lack of data from Alaska and Hawaii. Of those, the Palmetto State finished 47, with Louisiana the only state rated worse in home energy efficiency. The report also considered car energy efficiency, which also scored South Carolina among the nation's worst. The poor performance in both categories left the state at the bottom of the list.

"Charleston's population has increased by 13.1 percent over the past five years, more than three times the national five-year growth rate.

South Carolinians who buy their health insurance through the federal online marketplace have fewer choices than ever, with just one insurer remaining in the program raising premiums an average of 28 percent. BlueCross BlueShield is the only insurer offering 2017 policies in South Carolina through the exchange created by President Barack Obama's health law. Even its HMO subsidiary, BlueChoice, is no longer in the exchange. That means 114,000 people will have to change policies to stay insured, said state Department of Insurance Director Ray Farmer. As for the higher premiums, it's worth noting that 90 percent of the nearly 217,000 people covered by Healthcare.gov policies in South Carolina get federal subsidies that make premiums more affordable. That means that although BlueCross' plans are increasing between 14 percent and 31 percent, the rate hikes will be lower for people receiving subsidies. Meanwhile, BlueCross and other insurers are making similar premium increases

outside the marketplace, where customers don't get the federal subsidies.

South Carolina's fourth- and eighth-graders outperformed the national average on a federal science assessment administered last spring, according to their scores released Thursday. The National Assessment of Educational Progress, also known as the nation's report card, is the largest nationally representative assessment of student performance in core subjects. Among educators and policy-makers, the NAEP is widely considered the "gold standard" of standardized assessments. The test, administered every two years to a subset of fourth- and eighth-graders across the country, is one of the few that enables state-to-state comparisons for elementary and middle school students over time. Their scores are calculated on a 300-point scale. South Carolina was one of 14 states where scores in both grades rose. The state's 2016 results mirrored nationwide improvements among fourth- and eighth-grade students on the 2015 science assessment. About 4,600 fourth- and eighth-graders statewide took the assessment in the spring of 2015.

Coddington claimed that Williams, whom he met through a prostitution Web site, cuckolded him in his home, and then while drunk and on drugs, he beat and kicked her to death.

The Herald of Rock Hill reported (<http://bit.ly/2eAOMkv>) the 23-year-old John Coddington of Fort Mill pleaded guilty to murder in the death of 32-year-old Tiffany Williams. Coddington pleaded guilty Aug. 31 to beating Williams to death at his condominium late last year. Police said he took her body to Chester County and burned it in a barrel in an attempt to hide

the crime. He was sentenced to 45 years in prison as part of a plea deal to avoid a possible death sentence. Coddington wanted to back out of the plea agreement but the Court of Appeals rejected that request.

State investigators said they have dash camera video of the confrontation that led to a man being shot by a Greenville sheriff's deputy earlier this week. The man was shot at least once after authorities said he pulled a knife during a pursuit that began Tuesday afternoon at The Turning Point of South Carolina, an addiction recovery center on Bruce Road in Greenville. The State Law Enforcement Division is investigating the shooting at the request of the Sheriff's Office, said SLED spokesman Thom Berry. Berry said it was the fifth officer-involved shooting this year involving a Greenville deputy. Based on SLED records, it's also the first shooting at the Greenville County Sheriff's Office this year in which video footage exists. The Greenville News has requested to see the dash cam footage under the state's Freedom of Information Act. There is no body camera video of the confrontation, Berry said.

Columbia police spent three months looking for the son of a bank president after discovering one of the largest caches of illegal pills in city history near the University of South Carolina campus. The seizure in May worked, police said. Incidents involving mood-alerting drugs like Xanax have dropped at USC since discovery of nearly 40,000 pills at a storage unit inside the Aspyre at Assembly Station apartments at Assembly and Whaley streets. And Matthew Ryan Garnett, 23, was arrested on drug possession charges after he was nabbed in a Five Points-area scuffle last week, Columbia Police Narcotics Investigator Anthony Branham told Free Times. The son of NBSC President Chuck Garnett was released on \$15,000 bail, Branham said. After receiving a tip in May, police found 29,139 alprazolam (commonly known as Xanax) pills, 10,421 marijuana pills and 100 grams of hashish at a storage unit. The pills and narcotics had an estimated street value of \$200,000, police said.

Spartanburg County Sheriff Chuck Wright faces opposition in the upcoming election for the first time since he was elected sheriff. Wright has been sheriff since 2004 after defeating former Sheriff Bill Coffey in a runoff election. Both candidates agree that drug-related issues are among Spartanburg County's most critical public safety problems. They also acknowledge that deputy retention is a concern, but differ on the reasons for it and how to address it. They also both agree that body camera footage should be made public, but only under certain circumstances.

Three K-9 handlers assigned to the Florence County Sheriff's Office Criminal Enforcement Unit were acknowledged as some of the best in the nation at the American Police Canine Association (APCA) national conference last month. The team was awarded the United States Large Level Department Narcotics Interdiction Team of the Year for 2016 at the conference held Sept. 25 - 29 in Bloomington, Indiana. The award is given based on the agency's size, seizures of narcotics, illegal currency, apprehension and article finds such as weapons over the past year. The awards were presented to Corporal Shane Keith, Corporal Jamie Renfroe and Sergeant Austin T. Spell along with their respective canines Ruger, Roby and Una. From Sept. 2015 to Sept. 2016, the sheriff's office Criminal Enforcement Unit had combined seizures of 111 pounds of cocaine, 1655 grams of heroin, 109 grams of methamphetamine, 34 pounds of marijuana, and 319 doses of other controlled substances. The combined street value of the seizures totals upwards of \$5.8 million.

The State: Feds permanently shut a Columbia-area Liberty Tax Service franchise

A Columbia area Liberty Tax Service franchise owner has been permanently barred from preparing federal tax returns for others, the U.S. Justice Department said Thursday. A federal court issued a civil injunction prohibiting Christopher Paul Haynes from acting as a federal tax return preparer and from

supervising, managing or employing federal tax return preparers following an eight-month investigation. Haynes, of Irmo, operated Liberty Tax Service offices located at 2700 Broad River Road, 4058 West Beltline Road and 599 St. Andrews Road. The order issued Thursday also requires Haynes to provide the U.S. government with a list of all customers for whom Haynes or his businesses prepared a tax return for any tax year from 2010 to the present. The Justice Department said Haynes agreed to the injunction. On Feb. 8, the government sued Haynes alleging that he and his employees prepared false federal income tax returns at his three Liberty Tax Service franchises in order to increase customers' refunds.

Charleston Mayor John Tecklenburg has withdrawn a request to use \$150 million from the county's proposed half-cent sales tax referendum to pay for improvements near the new port terminal in North Charleston in exchange for moving forward with the extension of Interstate 526. But he has decided to support the \$2.1 billion spending plan for roads, public transit and green space anyway. In a Thursday letter to Vince Graham, chairman of the S.C. Transportation Infrastructure Bank board, Tecklenburg said he is rescinding the request that he and Charleston County Council Chairman Elliott Summey proposed in a Sept. 15 letter. That plan involved getting the \$150 million from a half-cent sales tax referendum that county voters will weigh in on Nov. 8. Tecklenburg said he is withdrawing the request because Graham indicated the Infrastructure Bank board won't meet before voters go to the polls.

Promising to curb traffic congestion, police students' off-campus behavior and to give neighbors more say in future developments, the University of South Carolina has won over neighborhood leaders for its plans for a massive student housing village on the south side of USC's downtown Columbia campus. USC made the promises during yearlong negotiations with seven neighborhood leaders. Those leaders said area neighborhoods were concerned about the possible consequences – namely in increased traffic and poor student behavior – of tripling the number of students living nearby. With the leaders' blessing, however, USC on Thursday unveiled its revised plan to transform 18 acres on the dilapidated south side of its campus into a 3,700-bed "Campus Village" bordered by Pickens, Heyward and Sumter streets.

Six months into Hillary Clinton's presidential campaign, she met with a group of Black Lives Matter activists in Washington to make her case and seek their support. DeRay Mckesson left disappointed, feeling Clinton lacked a grasp of the issues he had spent the previous year protesting in cities like Ferguson, Missouri, and Baltimore, including police brutality and income inequality. He came out of the October 2015 meeting unwilling to support her publicly. On Wednesday, though, The Washington Post published an op-ed by Mckesson announcing his plans to vote for her after meeting again with her last week in Cleveland. He said he heard a candidate well-versed in the things that matter to him. "There was no platform the first time," the 31-year-old Mckesson said in a telephone interview. "There is a platform now. I reflected on the things I've heard her say, commit to and seen in writing, and that's how I came to my decision."

Associated Press: Police evict oil pipeline protesters from private land

A months-long protest over the Dakota Access oil pipeline reached its most chaotic pitch yet when hundreds of law enforcement officers moved in to force activists off private property. Thursday's nearly six-hour operation dramatically escalated the dispute over Native American rights and the project's environmental impact, with officers in riot gear firing bean bags and pepper spray. Donnell Hushka, a spokeswoman for the Morton County Sheriff's Department, said 141 people were arrested. No serious injuries were reported, though one man was hurt in the leg and received treatment from a medic. Among those arrested was a woman who pulled out a .38-caliber pistol and fired three times at officers, narrowly missing a sheriff's deputy, according to State Emergency Services spokeswoman Cecily Fong. Officers did not return fire, she said.

World News:

Associated Press: Syrian rebels launch Aleppo offensive to break siege

Fierce fighting broke out around the northern Syrian city of Aleppo Friday as rebels announced a large-scale offensive to break the government's nearly two-month siege of opposition-held areas. A reporter inside the city on the Lebanon-based Al-Mayadeen TV channel reported attacks on "all sides" of the city, "from the furthest points north to furthest south." Sounds of heavy gunfire, mortar fire, and explosions were heard in the background of his broadcast. Dark smoke was seen rising above the city on the overcast morning. Presumed government or Russian jets were also heard flying overhead. Rebel factions in and around Aleppo have been preparing to launch a counteroffensive to try and break the government's suffocating siege off Aleppo's eastern-held neighborhoods for several weeks.

Associated Press: US says Iraqis have retaken 40 villages from IS near Mosul

The U.S. military says Iraqi forces have retaken 40 villages from the Islamic State group near Mosul since a massive operation to drive the militants from the city began last week. U.S. Air Force Brig. Gen. Matthew C. Isler said Friday that Iraqi troops are consolidating gains made east and south of the city earlier this week, but insisted "momentum" was still on their side. The fight to retake Mosul, which fell to IS in a matter of days in the summer of 2014, is the largest military operation undertaken in Iraq since the 2003 U.S.-led invasion. Isler says the U.S.-led coalition has stepped up airstrikes against the militants, and is carrying out three times as many as it did during previous campaigns to drive IS from other Iraqi cities.

Associated Press: Philippine leader Duterte says God told him to stop cursing

The foul-mouthed Philippine president, who once called the pope a "son of a bitch" and told Barack

Obama to "go to hell," says he has promised to God he won't spew expletives again. President Rodrigo Duterte's profanities have become his trademark, especially when threatening to kill drug dealers as part of his war on illegal drugs that has left thousands dead since he took office at the end of June. Duterte made the stunning pledge on arrival in his southern hometown of Davao city late Thursday from a trip to Japan. While flying home, he said he was looking at the sky while everyone was sound asleep, some snoring, and he heard a voice that said "if you don't stop epithets, I will bring this plane down now."
