Gov. Nikki Haley is being recognized for bringing manufacturing jobs to South Carolina. During a dinner Thursday in Spartanburg, Haley's office says she is receiving the 2013 Roger Milliken Defender Of Manufacturing Award from the South Carolina Manufacturers Alliance. Alliance CEO Lewis Gossett says Haley has been aggressive in recruiting new jobs to the state. Since Haley took office in January 2011, state commerce officials say South Carolina has announced 233 manufacturing expansions and openings.

Legal fees in the latest battle over a federally mandated computer system to track child support payments have hit \$3.6 million in just the last two years, according to a recent report in The Greenville News. increase even further before the year is out because the state is in the midst of an ongoing hearing that already has lasted six weeks.

People shopping for insurance on the federal marketplace may be informed they're eligible for Medicaid and that their information is being sent to state officials to sign them up. However, states aren't able enroll them because they're not receiving usable data from the Obama administration. The Center for Medicare and Medicaid Services wrote a memo to the 36 states using the federal website last week acknowledging the information wasn't being transferred automatically and saying another system was being developed to send it. More complete files could be sent as soon as next week.

A panel of state lawmakers will hear from South Carolina Treasurer Curtis Loftis and his complaints about how investments are handled for the state employee retirement system. The State newspaper reported (<http://bit.ly/IFDKqn>) that Loftis has complained for two years about what he calls corruption and wasteful spending at the state Retirement System Investment Commission. Four senators on Thursday are beginning a series of hearings on Loftis' charges that the commission that manages the \$26 billion retirement fund wastes millions of dollars on fees.

Greenville News: S.C. to lose \$807M in federal funds by not expanding Medicaid program, analysis shows

South Carolina stands to lose \$807 million in federal funds in 2022 by not expanding its Medicaid program as allowed under the Affordable Care Act, a new Commonwealth Fund analysis shows. "The Medicaid expansion presents an opportunity for states to bring in new federal dollars, in addition to providing critical health coverage for their low-income residents," said researcher Sherry Glied of New York University's Wagner Graduate School of Public Service. "No state that declines to expand the program is going to be fiscally better off because of it," she added. "Their tax dollars will be used to support a program from which nobody in their state will benefit."

Nobody knows when work will begin on the completion of the Mark Clark Expressway across Johns and James islands, despite the leap forward the project took Thursday. But it will be years. The state Department of Transportation Commission voted unanimously in favor of a revised contract for the completion of Interstate 526 at its regularly scheduled meeting. The vote marks the first concrete step forward for the long-stalled project since Charleston County Council voted to move ahead with it in December 2012.

A businessman charged in a public corruption case involving South Carolina State University wants to be tried separately from a former trustee, but prosecutors said in papers filed Thursday that two trials would be unnecessarily costly. Late last month, attorneys for Eric Robinson argued that being tried alongside Jonathan Pinson would "unfairly and irreparably prejudice" their client and deprive him of his right to due process. Robinson and Pinson were initially arrested in January as part of a kickback scheme involving the Orangeburg school.

Saying the government should lead by example, President Barack Obama on Thursday ordered the federal government to nearly triple its use of renewable sources for electricity by 2020. Obama said the plan to use renewables for 20 percent of electricity needs will help reduce pollution that causes global warming, promote American energy independence and boost domestic energy sources such as solar and wind power that provide thousands of jobs. The order is part of the president's wide-ranging, second-term drive to combat climate change and prepare for its effects.
