DESCRIPTION:

The College of Charleston requests approval to increase the project budget to accommodate additions to the original scope of work and to reflect a 37% increase in construction cost since the project was originally established. There is also an increase in A&E fees to reflect the increase in the cost of the construction.

Additions to the original scope include specifying a geothermal system to respond to the state's mandate to pursue sustainable design for its buildings; furniture, furnishings and equipment; information technology upgrades; permitting and inspection; and builders risk insurance.

E&G MAINTENANCE NEEDS REDUCTION:

The project will alleviate a portion of the \$179,149 in existing maintenance needs.

ANNUAL OPERATING COSTS/SAVINGS:

The Project is not expected to generate additional operating costs at this time.

RECOMMENDATION:

Staff recommends approval of this project as proposed.

DESCRIPTION:

Central Carolina Technical College requests approval to increase the project budget to provide for design and construction funding as required in Phase II – Construction PIP Submittal. The project was originally staff approved for an environmental study on November 20, 2006. On April 1, 2008 the project was staff approved for an increase of \$680,000, with a change in source of funds, revision of scope, and change of project name. At its meeting on June 5, 2008, the Commission on Higher Education approved the renovation of 44,000 SF of 68,000 SF in the Health Sciences building for \$9,000,000 as part of CPIP Year 1. The remaining renovation of 24,800 SF was included as a CPIP Year 2 project for \$4,500,000. This request revises the approval of June 5 to renovate the entire 68,800 SF building.

The building was donated by the City of Sumter to allow for the relocation of the health sciences programs. The programs are currently housed in a 27,260 SF facility along with the College's science programs. The current facility does not meet accreditation standards and is too small to allow the College to increase the number of graduates. The renovated space will allow the College to increase enrollment in its health sciences programs and science course offerings. The College needs to increase the number of graduates in order to respond to the growing nursing and health care worker shortages in the service area and in the state.

The College originally considered renovating a smaller portion of the existing building, but the majority of the costs are in infrastructure (electrical, roofing, HVAC, plumbing). Therefore, the cost savings did not warrant renovating less of the building.

The College also investigated the cost of demolishing the existing building and replacing it with new construction but found the cost would be \$80-\$100 more per square foot.

E&G MAINTENANCE NEEDS REDUCTION:

N/A – Space is being configured for proposed programmatic use.

ANNUAL OPERATING COSTS/SAVINGS:

Utilities, insurance, custodial services and supplies, building maintenance, and security will require additional operating costs ranging between \$134,916 and \$150,000 in the three years following project completion.

RECOMMENDATION:

Staff recommends approval of this project as proposed, pending approval by the State Board for Technical and Comprehensive Education (SBTCE) on November 12, 2008.

MEDICAL UNIVERSITY OF SOUTH CAROLINA

LEASE NAME: 5900 Core Avenue
REQUESTED ACTION: Lease Renewal
REQUESTED ACTION AMOUNT: \$162,000

DESCRIPTION:

The University requests approval of a lease renewal for 5,404 SF of space located at 5900 Core Avenue in North Charleston. The purpose of the renewal is to continue to provide office space for the Department of Psychiatry, Geriatric Research Center. An initiative is underway to relocate this group back on campus.

The monthly rental rate will be approximately \$9,000, resulting in an annual cost of \$108,000. The requested lease term is 18 months with extended terms to be negotiated. The total lease cost is \$162,000 with a rate of \$19.99 per SF. The requested lease is a full service lease; therefore, there are no additional operating expenses.

RECOMMENDATION:

Staff recommends approval of this lease provided the rates and terms are approved by the Budget and Control Board.

MEDICAL UNIVERSITY OF SOUTH CAROLINA

LEASE NAME: McClennan Banks, Fourth Floor
REQUESTED ACTION: Lease Renewal
REQUESTED ACTION AMOUNT: \$428,400

DESCRIPTION:

The University requests approval of a lease renewal for 9,653 SF of space located on the fourth floor of the McClennan Banks building. The purpose of this lease is to continue to provide office space for the Department of Psychiatry, Family Services Research Center.

The monthly rental rate will be approximately \$17,850, resulting in an annual cost of \$214,200. The requested lease term is 2 years, with extended terms of one term, two years, offered under the same terms and conditions. The total lease cost is \$428,400 with a rate of \$22.19 per SF. The requested lease is a full service lease; therefore, there are no additional operating expenses.

RECOMMENDATION:

Staff recommends approval of this lease provided the rates and terms are approved by the Budget and Control Board.

DESCRIPTION:

The University is requesting approval to establish a project to allow the College to perform pre-design services for a catering kitchen in the former Craig Cafeteria.

The College moved its central cafeteria to the George Street Complex in August 2007. The majority of the vacated space in the former cafeteria is being renovated for the Admissions operations under a separate project (9635). However, the kitchen and associated service areas of the vacated space are not included in the admissions renovation project.

The new food service operation at the George Street Complex has no central kitchen. All preparation is done in front of the customer at various stations throughout the facility. Therefore, the College is unable to use the new facility for catering purposes. The college intends to renovate the kitchen and associated service areas in the former Craig Cafeteria for use as a catering kitchen for the campus.

ANNUAL OPERATING COSTS/SAVINGS:

Sharon H. Thompson, Ed.D.

Dr. Sharon Howell Thompson, Professor and Coordinator of Health Promotion at Coastal Carolina University, was born in Greenwood, raised in Florence, and earned a baccalaureate degree from Clemson University. Later, she earned a master's degree, an educational specialist in administration, and an Ed.D. from the University of South Carolina-Columbia. She began teaching as an adjunct at Coastal in 1991, began full-time in 1993, started a minor in Health Education in 1995, and helped establish a major in this field in 1997.

Dr. Thompson credits her parents and her late husband as role models for becoming a teacher, an advisor, and a contributing member to family and community life. The mother of two daughters and a member of the Myrtle Beach First Presbyterian Church, she was also named by the Myrtle Beach Sun News as Volunteer of the Year in 2003. She has also chaired the Waccamaw Youth Center and the Horry County School District Comprehensive Health Education Advisory Committee.

Her work as a teaching faculty member has been universally admired on the campus. Since 1998 she has received several campus awards of distinction, including the 1998 Student Affairs Award and the 2004 Distinguished Teacher-Scholar Lecturer Award. As full-time teacher and advisor to 80 students annually, she still has found time since 2001 to sponsor students at the National Conference for Undergraduate Research (NCUR). She has been co-author of 20 published manuscripts and/or proceedings with students. She is also the University's Faculty Athletic Representative and advisor for the health promotion honor society.

Students are enthusiastic and expressive about her work with them. They speak of the time she takes to listen, her constant looking for opportunities for her students to succeed, her knowledge, kindness and sincerity—and, above all, her commitment. "As a part of a CCU awards ceremony," said one of them, "I was asked 'What is the best thing about Coastal Carolina University?' Without hesitation I replied, 'Dr. Sharon Thompson!'"

Charles S. Wilson, Ph.D.

Born the youngest of ten children and raised on a small family farm in Union County, SC, Mr. Charles Wilson graduated from Union High School, and worked in local industry for 23 years. He earned his A.S. from Spartanburg Technical College in Machine Tool Technology and attended Clemson's program in Human Resource Development/Vocational Technology.

Wilson credits several people in his life for his becoming a successful teacher. Several of his older brothers had dropped out of school to help with farm work so that the others in the family could attend school. His first Union County schoolhouse was three rooms. "We had small classes, and the teachers really cared for each student," he remembers. At Spartanburg Technical College where he excelled, his instructor, Aubrey Owens, took the time to mentor and encourage him to pursue his studies rather than join the Navy. Wilson has carried the legacy of caring for students into his classrooms at Greenville Tech, where he has been on the faculty since 1989. Many students whom he has taught, advised, and mentored attest to his strengths in all these capacities. One of these students had lost his job when he was working on a degree. Learning about this situation, Mr. Wilson contacted an industry representative with whom he worked on an advisory committee and was able to get the student tested and into a new position immediately. "It has changed my life," says that student, who adds that "Charles Wilson stands behind his words and instructs his students not only in the classroom, but his advice reaches no boundaries."

Wilson has been able to help students, too, by his relentless commitment and impressive energy in promoting linkages with local business and industry in the Greenville area, where he engages the managers in the private sector as members of advisory committees to improve his teaching constantly. His work at the local level has gained him the attention of the US Secretary of Labor, Elaine Chao, who appointed him to a second two-year term as a member of the Advisory Committee on Apprenticeship. His students' welfare always is front and center in these activities, prompting one plant manager in Greenville to say that Wilson's efforts are preparing the workforce to the next level of excellence. Dr. Keith Miller, Greenville Technical College's president, has said of Mr. Wilson, "He goes above and beyond for his students because he genuinely cares about them, their futures, and the future of our country's workforce."

ACT 629 OF 1988 (THE "CUTTING EDGE" LEGISLATION) ESTABLISHED THE GOVERNOR'S PROFESSOR OF THE YEAR AWARD. EACH PUBLIC AND PRIVATE INSTITUTION COULD NOMINATE ONE PERSON AS A DISTINGUISHED PROFESSOR FROM THEIR INSTITUTION.

IN 1996—LAW WAS AMENDED TO ALLOW FOR A TWO-YEAR AND A FOUR-YEAR INSTITUTIONAL WINNER.

EACH WINNER RECEIVES A CITATION AND A CHECK FOR \$5,000.

SINCE 1988 (THROUGH 2008), A TOTAL OF 34 FACULTY MEMBERS HAVE BEEN HONORED WITH THIS ANNUAL AWARD, INCLUDING:

- 15 FROM PUBLIC SENIOR INSTITUTIONS
- 6 FROM PRIVATE SENIOR INSTITUTIONS
- 13 FROM PUBLIC TWO-YEAR INSTITUTIONS.

FINALISTS ARE CHOSEN BASED UPON WRITTEN NOMINATIONS, SUPPORTING MATERIALS, AND INTERVIEWS WITH THE COMMITTEE.

Professors change students lives and those changed lives change the society in which we live for the better.

Dr. Thompson not only teaches her subject and advises her students, but also has built an entire academic major on the campus of Coastal Carolina and works with the school districts along the I-95 corridor to change personal habits in eating and health to increase the quality and longevity of life.

Mr. Wilson teaches and advises students, too—and the stories of his work with them to get them the right apprenticeship or job experience in industry are legendary. In addition, he is on national advisory panels—including one in the US Department of Labor for advising Ms. Chao, Secretary of Labor, on apprenticeships.

It is coincidental, but nevertheless another reason to celebrate, that each of these individuals was born, raised and educated, and has made his/her entire career in South Carolina. Dr. Thompson, Mr. Wilson, you are both at least as impressive as your resumes make you seem—and clearly individuals in whom the whole state can take pride for your accomplishments.

I salute Dr. Thompson and Mr. Wilson today for being teachers, advisors, mentors, role models and advocates for their students. I thank them for giving their students a sense of hope in their futures; for bringing out the creativity in their lives; for requiring them to be reflective to ask what they owe to their communities. On behalf of the Commission, I say "Congratulations!" and would ask that you each introduce your colleagues and family who have accompanied you today and say a few words to us—first, Dr. Thompson and then, Mr. Wilson.

REMARKS PREPARED FOR DELIVERY AT PROFESSOR OF THE YEAR (2008) LUNCHEON AT CAPSTONE HOUSE—USC-COLUMBIA

CHAIRMAN OF COMMISSION: Good afternoon and welcome to the 21 South Carolina Governor's Professor of the Year Awards Luncheon. I am Layton McCurdy, Chairman of the Commission on Higher Education, and it is my pleasure to preside over this event which honors the two Professors of the Year—one selected to represent two-year and one to represent four-year institutions. Also with us today are the eight faculty finalists in that process.

I want to recognize the members of this year's Selection Committee, who have been chosen from throughout the state for their interest in and knowledge of higher education.
