Dear Governor Haley:

I am writing to you just because my daughter insisted you may be the only one left that can assist me. I love what you have done for SC and hope you continue to do the same for the foreseeable future.

I am a 63 year old working women. I have raised two wonderful and successful children in the sate of NY as a single Mom. I supported them and raised them to believe in the government, laws of God and country and was blessed. Between the three of us, none have collected food stamps, unemployment or been arrested. Here is my story: I have been a apartment complex manager since 1982 in NY and now in SC since 2006. I was diagnosed with throat cancer in 2009. With Obama/Clinton health insurance, nothing was paid for by insurance. I worked threw chemo and radiation and was forced to declare personal bankruptcy in 2011. I thought I had my bills under control, up until I received the final bill from the radiation doctor for \$208,000.00. This is after I had ran threw my savings and taken out a second mtg on my home. I still continued to pay for my useless insurance because it was against the law not to. I continued to work for the same complex in SC. In 2014 the owners informed me that the complex was once again up for sale. They promised (and begged) for me to remain in charge until the sale and to work to faithfully help assist in the sale (showings to new interested owners) they promised me a bonus of \$15,000.00 when and if the complex sold. I have since needed skin cancer removed extensively from my nose and now arm which I have paid for by myself while still paying for health insurance with a \$5,000 or \$6,000 deductible.

On December 28, 2015 the complex was sold to new owners. Full taxes were taken out of my \$15,000.00 bonus. When I filed my taxes however, I was informed the due to Obama/Clinton insurance, I was being fined \$8,800.00 because I lied about my income.

In truth Governor, the complex sale could have gone on for five years. I did not lie about my income. I reported immediately to the health care system when my now husband began collect his early SS in 2014 and paid the difference. I do not think this is fair or just. I called tax lawyers and they will only talk to you if you owe \$10,000 or more. I didn't even have the Consumer choice insurance for at least three months in 2015.

With the \$15,000.00 bonus, I was able to pay off my bankruptcy, and the second mtg I had on my home. My intentions were to put in for my social security when the complex sold and get a part time job. Now, I have a \$150.00 payment to the IRS every month and Its really not right. I worked all my life to raise my children right and now I'm not so sure that was the best thing to do.


