The FHWA website contains a lot of great information such as the attached table that shows the payments into the Highway Trust Fund, Apportionments and Allocations from the Federal Highway Trust Fund and the related ratio.

<https://www.fhwa.dot.gov/policyinformation/statistics.cfm> You will be able to find historical data at this site as well. The most recent funding and authorization bill to govern US federal surface transportation funding is referred to as MAP-21 and I have attached a summary for your reference. One of the components of MAP-21 was to guarantee 95% minimum dollar rate of return 2 years in arrears.

I have also attached a copy of the FY2014 computation table that allows you to see the more analysis of how funds are apportioned to South Carolina. These tables detail the increase in that year to coincide with the 95% minimum rate of return.

Additionally, you asked how the Federal Gas and diesel tax is spent in South Carolina and I am attaching SCDOT's Federal Funding Plan for 2013-2016. These are based on a Federal vs State fiscal year of October 1 – September 30.

Although SCDOT receives state gas tax funds monthly, federal gas tax funds are reimbursements and received at SCDOT after the presentation of a request for Federally eligible expenses.

- 1) How much federal gas and diesel tax did SC generate in FY 2013-14, FY 2014-15, and FY 2015-16? We can estimate this with the number of gallons if you do not have this data.
- 2) How much of the federal gas and diesel tax did SC receive for FY 2013-14, FY 2014-15, and FY 2015-16? How were the funds spent?
