This MOU may be amended from time to time by mutual written agreement of the Parties. No Party may withdraw from this agreement without prior written consent of the Signatories, except that a Party may unilaterally withdraw from this MOU on July 1 of any year, after providing thirty days (30) written notice to [the other Party/Signatory – however you want to word it]. Parties participating in this MOU shall have identical standing regardless of their dates of execution.
