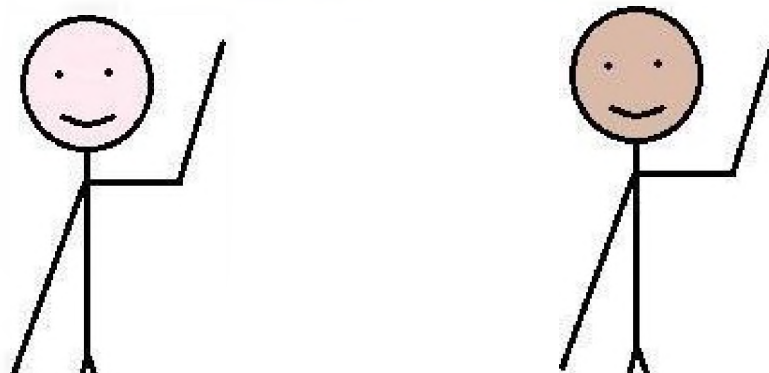

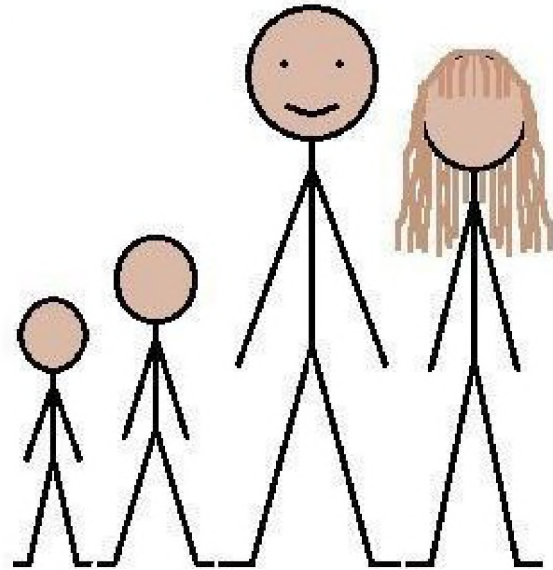
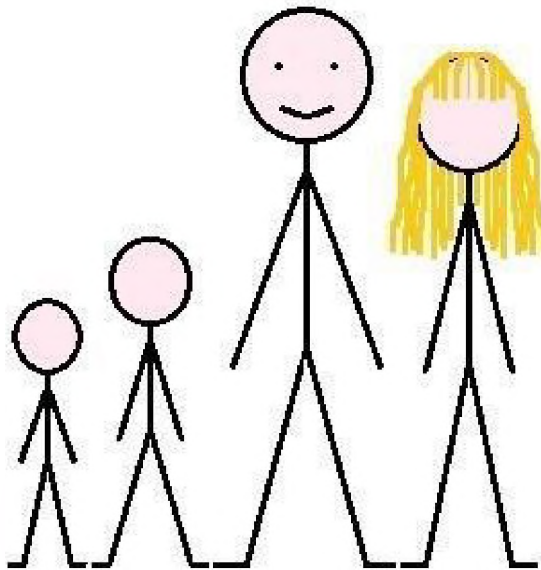
Explained as if you were 5 years old.

Meet John Legal and Juan Illegal.

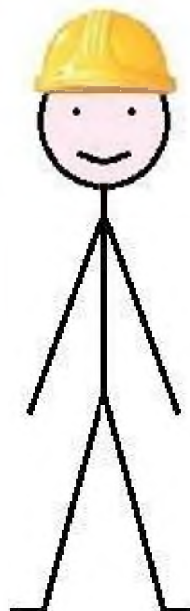




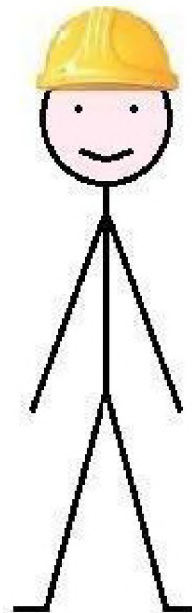
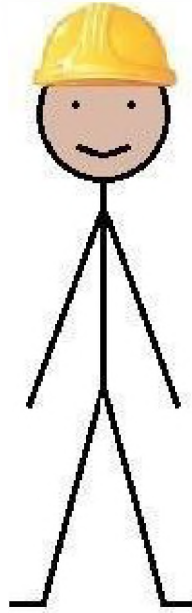
Both have a wife and two children and live in Arizona.



John Legal works in construction, has a Social Security Number and makes \$25.00 per hour with taxes deducted.



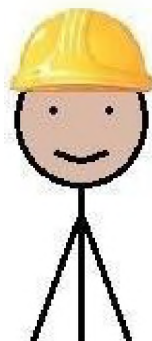
Juan Illegal also works in construction, has NO Social Security Number, and gets paid \$15.00 in cash “under the table”.

Now take 30% away for state and federal tax.

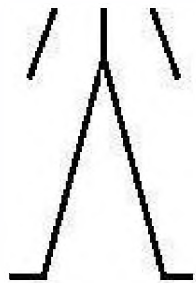
John Legal now has \$36,400.

John Legal seems to be in better shape.

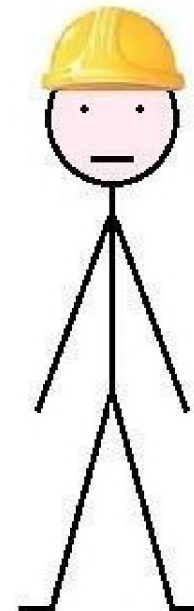
BUT:

John Legal pays rent of \$1,200 per month, or \$14,400 per year.

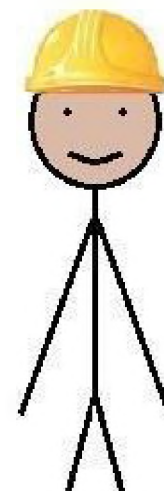
John Legal now has \$8,800.



Juan Illegal has full medical and dental coverage through the state and local clinics and emergency hospitals at a cost of \$0.00 per year.

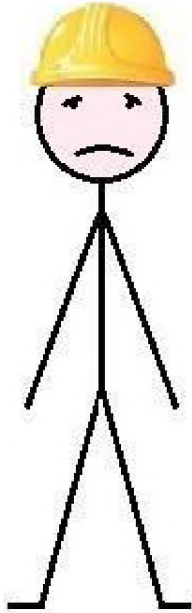
Juan Illegal has no documented income and is eligible for food stamps, WIC and welfare.

Juan Illegal receives a \$500 per month Federal Rent Subsidy. Juan Illegal pays out that \$500 per month, or \$6,000 per year.



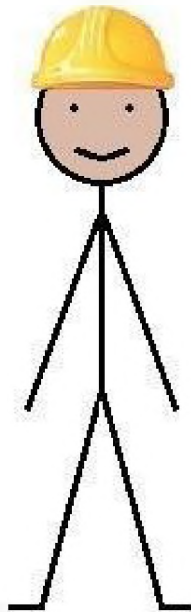

John Legal now works overtime on Saturdays or gets a part time job after work.



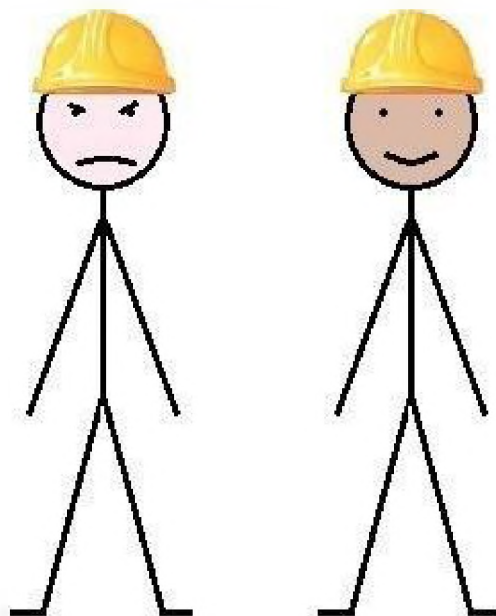
Juan Illegal has to make his \$31,200 stretch to pay utilities, gasoline, etc. and what he sends out of the country every month.

But wait. What about the children?

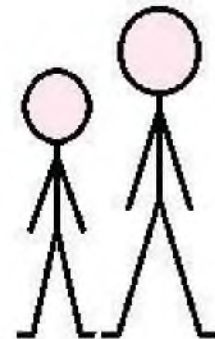




Well, both John Legal's and Juan Illegal's children attend the same elementary school.

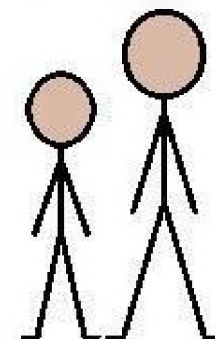
John Legal pays for his children's lunches, while Juan Illegal's children get a government sponsored lunch.

Juan Illegal's children have an after school ESL program. John Legal's children go home.

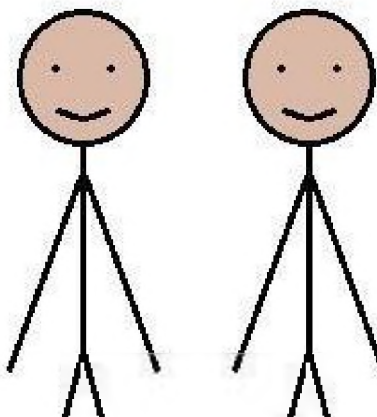


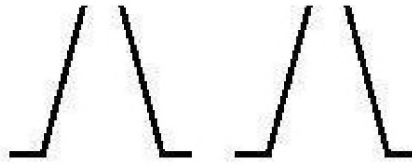
When they reach college age, John Legal's kids may not get into a State School and may not qualify for scholarships, grants or other tuition help, even though John has been paying for state schools through his taxes.

Juan Illegal's kids "go to the head of the class" because they belong to a minority, and have a much higher chance to get a free college education.

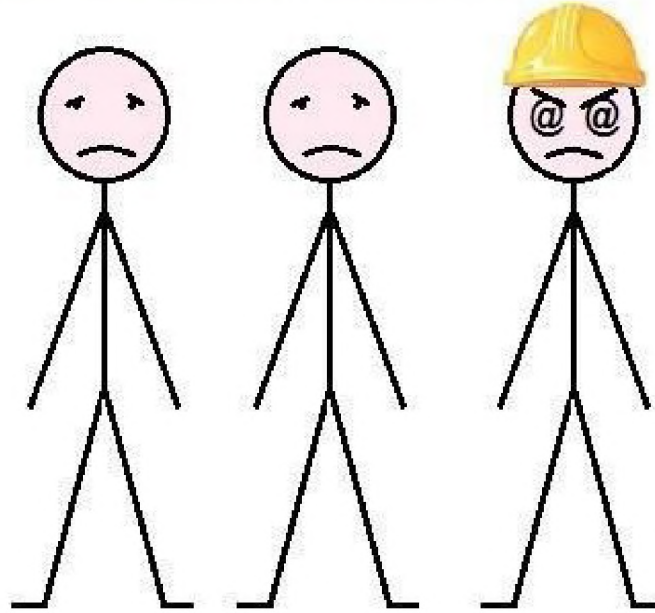
