#### Gorsuch's Credentials Could Prove Troubling To Opposition

The praise for Tenth Circuit Judge Neil Gorsuch following his nomination to the U.S. Supreme Court Tuesday night came from many prominent legal figures, reflecting how it will be hard for Democrats to challenge President Donald Trump's selection given the judge's impeccable resume.

#### Gorsuch Likely To Restore Scalia-Era High Court Balance

With a solid conservative bent, President Donald Trump's nominee for the U.S. Supreme Court, Circuit Judge Neil Gorsuch, is unlikely to shift the high court's jurisprudence significantly away from where it stood with the late Justice Antonin Scalia, legal experts say.

#### Trump Nominates Judge Gorsuch For High Court Seat

President Donald Trump on Tuesday nominated Tenth Circuit Judge Neil Gorsuch to fill a Supreme Court seat that has remained vacant since the death of Justice Antonin Scalia in February 2016, picking a well-respected figure in the conservative legal establishment who would restore the nation's top bench to a Republican majority and likely break the recent spate of 4-4 ties.

### **Dems Boycott Vote On Trump's HHS, Treasury Noms**

Senate Democrats on Tuesday staged a rare boycott of committee votes on President Donald Trump's choices to lead the U.S. Department of the Treasury and the U.S. Department of Health and Human Services amid questions on whether the nominees gave false statements in testimony.

Republican lawmakers in Congress will vote Wednesday to disapprove a U. S. Securities and Exchange Commission rule requiring oil and gas extraction companies to disclose their payments to foreign governments, potentially preventing the agency from implementing the regulation.

### Flint Residents File \$772M Suit Saying EPA Ignored Lead

A group of about 1,700 residents of Flint, Michigan, filed a \$772 million joinder suit in Michigan federal court on Monday against the federal government, alleging that the U.S. Environmental Protection Agency injured local residents by ignoring the dangers of elevated lead found in the city's drinking water.

### Republicans Move To Block Obama Stream, Methane Rules

Republican lawmakers from both congressional chambers floated pieces of legislation Monday to repeal controversial Obama administration rules aimed at minimizing coal mining's harm to surface water and groundwater and limiting methane releases from drilling operations on federal and Native American lands.

### Trump's Interior, Energy Noms Coast To Final Senate Vote

Secretary of the Interior nominee Ryan Zinke and Secretary of Energy nominee Rick Perry were easily approved by the Senate Committee on Energy and Natural Resources on Tuesday, paving the way for their likely confirmation by the full Senate.

### FEC Beats Suit Over Lack Of Probe In Murray Energy Donation

A D.C. federal judge on Monday tossed a lawsuit challenging the Federal Election Commission's decision not to investigate allegations that Murray Energy Corp. and its president strong-armed employees into making donations to coal-friendly federal political candidates and the company's political action committee.

### Trump 'Sabotaging' ACA By Curbing Outreach, Dems Say

The Trump administration is "sabotaging" Affordable Care Act sign-ups by curtailing consumer outreach, and it should allow extra enrollment time to offset the damage, prominent congressional Democrats said in a letter Monday.

### House Passes DHS Internal Security, Israel Sharing Bills

The House passed a series of bills Tuesday to alter U.S. cybersecurity policy, ranging from greater internal controls against the next leaker at the U.S. Department of Homeland Security to international cooperation with Israel.

### **DHS Officials Try To Clarify Exec. Order Amid Confusion**

Homeland Security officials on Tuesday attempted to address confusion over President Donald Trump's executive order temporarily banning nationals from several Muslim majority countries, with the DHS secretary insisting it was "not a ban on Muslims," and a U.S. Customs and Border Protection official clarifying that dual nationals won't be affected.

### **San Francisco Sues To Challenge Trump Sanctuary City Order**

San Francisco sued President Donald Trump Tuesday in California federal court over his executive order directing the government to withhold federal funds from cities that have sanctuary policies limiting local involvement with federal immigration enforcement, blasting it as "a severe invasion of San Francisco's sovereignty."

### **Mass. AG To Sue Trump Over Immigration Order**

Flanked by the state's educational, health care and technology leaders, the Massachusetts attorney general announced Tuesday that she was intervening in a federal lawsuit against President Trump's immigration executive order.

### **FCC's Pai Favors 'Open Internet' But Mum On Plans**

Federal Communications Commission Chairman Ajit Pai said he favors a "free and open internet" while opposing the reclassification of broadband providers under common carrier regulation at his first meeting as chief Tuesday, focusing instead on action to close the digital divide.

### **New FCC Won't Defend At DC Circ. Parts Of Inmate Call Caps**

Republicans newly at the helm of the Federal Communications Commission told the D.C. Circuit Tuesday that the commission will not defend two aspects of an attempt to cap inmate calling rates by the previous FCC in court next week, backing off from capping intrastate rates.

### **Globalstar Can Use Its Bandwidth For Broadband, FCC Says**

Satellite telecommunications provider Globalstar Inc. has gotten the green light to use its current spectrum for terrestrial broadband after narrowing an earlier request for expansion, according to a final rule the Federal Communications Commission published in the Federal Register Tuesday.

### **Franken Urges Pai, A Net Neutrality Foe, To Keep It Alive**

Sen. Al Franken, D-Minn., pressed the Federal Communications Commission's brand-new chairman, Ajit Pai, on Monday to reverse his opposition to the commission's 2015 order enshrining the principle of net neutrality, calling it the "First Amendment issue of our time."

### **FCC Is Asked To Reopen Broadcast Communication Channels**

Washington, D.C., law firm Wiley Rein LLP urged the Federal Communications Monday to drop rules barring certain communications by TV broadcasters during the ongoing broadcast incentive auction, saying their portion of the sale is complete and there is no risk of an effect on bids or

strategies.

## **States Urge DC Circ. to Reject FCC Lifeline Change**

A coalition of 12 states and state utility commissions urged the D.C. Circuit Monday to quash a move by the Federal Communications Commission to create a federal process to confer eligibility to telecom companies to deliver Lifeline broadband services.

### **Some Context For Trump's New Immigration Executive Order**

President Donald Trump's recent immigration-related executive order has sown confusion and spurred anger in the few days it has been in effect. In addition, arguments are raging over the White House's claims of precedent for the order and the implications of implementing "extreme vetting," says Jonathan Meyer, partner at Sheppard Mullin Richter & Hampton LLP and former deputy general counsel of the U.S. Department of Homeland Security.

### **An Analysis Of Wilbur Ross' Stance On Trade Remedies**
