Dear Ms. Veldran – I am writing to provide you an update on the encroachment permit for Mr. Bill McDaniels in Richland County. As stated below, my staff reviewed the initial application for encroachment permit and provided comments to the engineer for this development. Please see the attached email and letter dated March 26th that detailed our initial list of comments. We look forward to their response / resubmittal to continue our review process. Our staff will continue to work closely with Mr. McDaniels' engineer to review this permit in an expeditious manner.

Additionally, Director of Right of Way Brian Keys continues to negotiate with Mr. McDaniels on a financial settlement for the break in control of access. As stated my letter dated December 31, 2014 (attached), the approval for the break in control of access is contingent upon 1) a mutually agreeable financial settlement and 2) the driveway will meet all SCDOT Access Roadside Management Standards (ARMS).
