The Department of Health and Human Services is hosting a meeting on Monday, December 10th from 1:00 - 4:45 which will focus on Value Based Insurance Design (VBID).

The meeting will be located at the SC Department of Employment and Workforce (C. Lem Harper Building), 631 Hampton Street, Columbia, SC.

The mission of VBID Health is to get more health out of every health care dollar. As public and private health care payers explore innovative strategies that reward improved clinical outcomes rather than increased volume of services, VBID Health helps clients better understand the opportunities and challenges regarding the design, implementation, clinical effects, and economic impact of new payment models (e.g., global budgets, pay for performance, risk sharing, bundled payments, tiered networks and accountable care organizations) and consumer engagement initiatives (e.g., shared decision-making, literacy, "clinically nuanced" Value Based Insurance Design). Through the creation of programs that align incentives for both providers and consumers, VBID assists health care stakeholders in achieving the important goals of improving quality and containing costs.

The meeting will focus on SC's strategy, short term goals and challenges:

- ways to integrate VBID principles into the SC Medicaid program, including the Medicaid reimbursement mechanisms and Medicaid covered benefits
- ideas to expand the work underway in SC regarding payment reform in the Medicaid program, including the existing risk withhold and incentive mechanisms
- strategies to coordinate benefit designs and payment reform initiatives across multiple payers so providers have one clear payment reform strategy that incentivizes improved outcomes and increased care coordination
- additional strategies for improving outcomes and ensuring the covered benefits are clinically nuanced
