Ken Griffey, Jr.

- Has been an investor with Warner Peacock for many years.
- Born in Donora, Pennsylvania.
- Griffey is one of only 29 players in baseball history to date to have appeared in Major League games in four different calendar decades.
- On August 10, 2013, Griffey became the seventh person inducted into the Mariners' Hall of Fame.
- He played for the following teams:

- He is the son of former MLB player Ken Griffey, Sr.

Here are just a few items for Gov. Haley to know in preparation for the Jaguar Land Rover Columbia grand opening event on Thursday:

- New River Auto Mall is an automotive sales group based in Hardeeville South Carolina with dealerships in Columbia, Augusta, Florence, and Greenville.
- New River Auto Mall purchased two existing dealerships – Jaguar Columbia and Land Rover Columbia, in February of 2014, and combined them into one. We have been operating out of the old Land Rover dealership for the past year, and are excited to be in the new building, now. The former dealership is now our parts and service department.
- The new combined dealership, Jaguar Land Rover Columbia, represents the company's current commitment to the market in Columbia, and our parent company, Coastal States Automotive Group, is looking to grow in this market.
- New River Auto Mall currently employs 42 people in the local community and its holding company, Coastal States Automotive Group LLC employs almost 500 people in South Carolina and Georgia.
- It is part of our corporate philosophy to be active citizens in our community - we support a variety of non-profit organizations, both at our parent company location in the S.C. Lowcountry and here in Columbia.
 - The company's philanthropic activity includes partnerships with the Boys and Girls Clubs of the Lowcountry and the American Heart Association and many other organizations.
- **President & CEO, Warner Peacock, was nominated by Gov Haley (January of this year) and confirmed by the S.C. Senate for a three-year term to serve on the S.C.
