

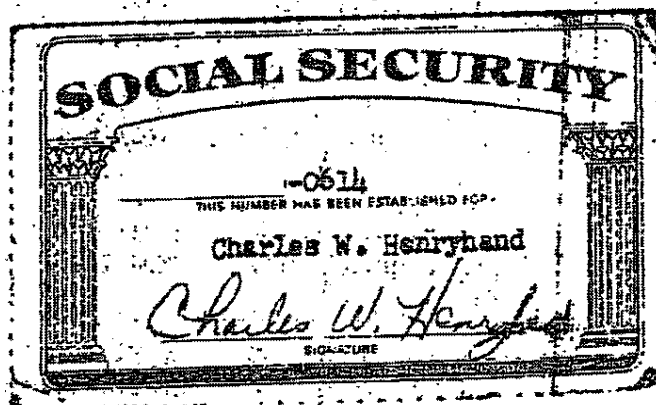

An indictment (/mˈdɑːrtmənt/ *in-DYT-mənt*), in the common law system, is a formal accusation that a person has committed a crime. In jurisdictions that use the concept of felonies, the most serious criminal offence is a felony; jurisdictions that do not use the concept of felonies often use that of an indictable offence—an offence that requires an indictment.

Historically, in most common law jurisdictions, an indictment was handed up by a grand jury, which returned a "true bill" if it found cause to make the charge, or "no bill" if it did not find cause.

## United States

The Fifth Amendment to the Constitution of the United States states in part: "No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia when in actual service in time of War or public danger".

In many, but not all, United States jurisdictions that use grand juries, prosecutors often have a choice between seeking an indictment from a grand jury and filing a charging document directly with the court. Such a document is usually called an information, accusation, or complaint, to distinguish it from a grand-jury indictment. To protect the suspect's due-process rights in felony cases (where the suspect's interest in liberty is at stake), there is usually a preliminary hearing, at which a judge determines whether there was probable cause to arrest the suspect who is in custody. If the judge finds such probable cause, he or she binds, or holds over, the suspect for trial.

The substance of an indictment or other charging instrument is usually the same, regardless of the jurisdiction: it consists of a short and plain statement of where, when, and how the defendant allegedly committed the offense. Each offense usually is set out in a separate *count*. Indictments for complex crimes, particularly those involving conspiracy or numerous counts, may run to hundreds of pages. However in other cases an indictment for a crime as serious as murder, may consist of a single sheet of paper.

### David A. Thomas—Special Agent in Charge

David A. Thomas was designated a special agent of the FBI in 1989. After completing more than a dozen years of supervisory and leadership roles in areas such as violent crime, domestic terrorism, and national infrastructure protection, Mr. Thomas was appointed chief of the Cyber Division's Criminal Computer Intrusion Unit in 2001. He was promoted to assistant special agent in charge of the St. Louis Division in April 2003 and returned to FBI Headquarters in July 2004 as section chief of Counterterrorism/Counterintelligence and Criminal Computer Intrusion Investigations in the FBI's Cyber Division. In this capacity, Mr. Thomas directed the FBI's efforts on all major transnational cyber investigations and was responsible for the creation of Cyber Action Teams, which deploy domestically and internationally in response to major cyber events.



Mr. Thomas was selected as the deputy assistant director for the Science and Technology Branch in September 2006, where he was responsible for providing the vision, leadership, and direction for the branch. Under his purview, he ensured the operational availability of state-of-the-art technologies and the support and expertise necessary to enable and enhance the FBI's intelligence and investigative-related mandates. In addition, Mr. Thomas oversaw the application of forensics services related to the collection, processing, and exploitation of computer and audio visual media in the counterintelligence, counterterrorism, criminal investigative, and cyber program areas. Mr. Thomas actively fostered the branch vision to create and supply "world class" tools and technologies in support of the FBI's mission to prevent and deter terrorism and crime and to protect U.S. national security.

In November 2007, Mr. Thomas began serving as special agent in charge of the Columbia Division of the FBI in South Carolina.
