Subsequent to our telephone conversation of July 30, 1979, I have polled the Board members as to whether the reallocation approved by the Personnel Division in January for the SLED agents and criminologists can be implemented under the prior policy that allowed each employee whose position was reallocated to receive money. You will recall that we had approved a reallocation in January for SLED agents and that SLED had notified the agents and criminologists that the salary increases would be implemented in July with a special appropriation being requested. SLED did receive an appropriation for this purpose, but in the meantime the Board had adopted a new policy that allows money to be received in reallocation actions only in the amount necessary to take the individual to the minimum of the higher grade.

Kitty Clark voted affirmatively for the Governor. Senator Dennis was on vacation. Messrs. Patterson, Morris, and Mangum all voted to allow these reallocations to be implemented under the old policy. These reallocation increases will be effective at the beginning of the next pay period.
