Mr. Poore was still in the hospital and unable to attend. Mr. Rhodes called the meeting to order and Councilman Bratcher gave the invocation.

Mr. Rhodes explained that the Historical Society was promised space several months ago. Mrs. Stathakis asked Council for museum space in the Courthouse. Mr. Rhodes stated that the Magistrate's office would be moving out to the County Farm House. On the motion of Mr. Kinley, seconded by Mr. Hooper, Council voted unanimously to designate Magistrate Whitfield's office space for the Historical Society.

Mr. Walters stated that he had a list of the patching that has been done. \$14,000 in July, \$16,500 in August and almost \$16,000 in September for a total of \$46,815. He stated that \$70,000 was appropriated and there would be a balance of \$23,185 still remaining for patching. Mr. Walters reported that none of the tar and gravel has been started and that all the patching was finished in #10, and work was being done in district #8. Council discussed roads approved for resurfacing.

Mr. Rhodes stated that Mr. Guffey said that the lower assessment rate^{period} could still be extended. On the motion of Mr. Kinley, seconded by Mr. Bratcher, Council voted unanimously to extend the filing period and to run a public notice in the newspaper one week before Mr. Guffey cuts off.

On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to hold a public hearing at the next regular meeting and have someone from the S.C. Tax Commission present to answer questions regarding reassessment.

Mr. Guffey, Assessor, asked Council to hear an appeal from an employee that was layed off due to the combining of departments. Council agreed to hear this appeal at their next meeting.


