The Budget Commission met in the Governor's Office at 5:00 o'clock P. M. on September 23, 1942, all members being present.

The following transfers were approved by the Commission:

The Commission declined to grant a transfer to the Public Service Commission for the purpose of increasing the salary of the Chief Engineer, in line with its general policy of granting no transfers which are intended to increase salaries.

The following allotments were granted from the 1942-43 Civil Contingent Fund:

Clemson College, Public Service Activities, \$1,000.00 for Control of the Japanese Beetle.
The R. L. Bryan Co., \$126.40 Office Equipment for the Governor's office.

The following allotment was made from the Contingent Fund for National Defense:

South Carolina Aeronautics Commission \$1,000.00, for Emergency Attorney Fees.

The following payments were approved from the 1941-42 Civil Contingent Fund:

Roper Hospital \$81.50, for services rendered to Miss Gladys Thompson.

Miss Gladys Thompson \$8.00, to cover bill of Dr. Robert W. Gatlin, Jr., for glasses.

The Commission declined to grant a request from the State Board of Health for an allotment of \$4500.00 from the Civil Contingent Fund for employing five additional clerks, and for \$1500.00 for Office Supplies. The Commission decided that the balance in the Civil Contingent Fund was insufficient to justify these allotments.

The Commission declined to grant a request from the South Carolina Development Board for an allotment from the Civil Contingent Fund to defray certain expenses of the Board, because of insufficient funds.

A communication was received from the Department of Public Welfare, stating that the Work Projects Administration had discontinued the payment of salaries of twelve warehouse supervisor. The Commission agreed that if the State Department would retain these employees at their present salaries, paying the salaries from the appropriation for the State Department, the Commission would support a deficiency appropriation amounting to \$9,571.76, at the coming session of the General Assembly; and the Secretary was ~~re-~~ requested to advise the Director of the State Department.

The Commission then adjourned.
