Circuit Judge **Markley Dennis** weighed various factors, including facts of the case and whether Loftis is a flight risk or a danger to the community, in considering bail during a hearing Monday in the Berkeley County Courthouse. Loftis' emerging self-defense plea indicates that it's likely he won't run away, the judge noted. “**The only way he will ever be able to resolve that is to ... have his day in court,**” Dennis said.
